Latino Cultural Center Phase II Naming Rights Components Public Comments

For capital campaign acknowledgments, Cultural Policy (Council Resolution 18-1683, passed on November 28, 2018) provides for naming opportunities to increase sustainability of the arts ecosystem and Office of Arts and Culture (OAC) buildings. The Cultural Policy requires that contributions related to naming rights must be dedicated in part to facility needs. The Latino Cultural Center (LCC) consolidated capital campaign follows policy, with 100% of contributions dedicated to the LCC Phase II project. Naming proposals for received contributions must undergo a 30-day public comment period on OAC's website and other applicable public forums.

Following the 30-day comment period, the Arts and Culture Advisory Commission will vote to recommend to the Director the following named areas within LCC Phase II listed below. Recommendation in support of artist's design by Brad J. Goldberg for Crawford Memorial Park Peninsula Public Art Project at Crawford Memorial Park in Council District 5

BACKGROUND

The Public Art Program of the City of Dallas Office of Arts and Culture requested the submission of qualifications from artists or artist teams to design, fabricate and install a work of public art at Crawford Memorial Park. Public Art Staff hosted community meetings to request information from the community about the final scope of project including content and style. The draft scope of project was presented to the community and the scope was part of the published Request for Qualifications.

Brad J. Goldberg was selected for the Crawford Memorial Park Public Art Project in CD 5. He completed Phase 1 of Master Planning in 2011. The project was approved by the Park and Recreation Department but was on hold until funding became available. The project has been reinitiated at this time.

SCOPE OF PROJECT

The scope of the project is a site-specific installation of artist designed and fabricated community tables and seating. This public gathering space will provide a location for community gatherings and other community programming.

ARTIST BACKGROUND

Artist Brad J. Goldberg was recommended for this public art project by the Selection Panel composed of artists, community members, and representatives from the Park and Recreation Department.

Artist Brad Goldberg creates artwork this is a fusion between sculpture, landscape, and the built environment. Sculptures are created, not as isolated objects, but rather as components of larger spatial experiences. Working with the environment as a whole allows the creation of a unique places for community gathering. This approach is consistent with contemporary directions for public art known as placemaking.

Brad is an artist who works collaboratively with artists, design professionals, civic leaders, and communities. Whether working with architects and engineers, craftsmen and

contractors, or fabricating his own work, Brad is experienced in dealing with the complexities of creating an artwork within outdoor environments.

Brad has worked internationally on similar projects for over 30 years.







SUBJECT

Recommendation in support of the FY 2022-23 Cultural Organizations Program Guidelines

BACKGROUND

The updated Cultural Policy of the City of Dallas, adopted on November 28, 2018, provides that guidelines for the various Cultural Funding Programs will be submitted annually for review and approval of the City Council. This serves to affirm the artistic nature of services to be provided through these various cultural programs and to specify the review and selection process for cultural services.

The Cultural Organizations Program (COP) is the support program through which the Office of Arts and Culture contracts for a full season of cultural services with established non-profit organizations for a variety of cultural programs that include concerts, plays, exhibitions, performances, workshops and other cultural programming for the benefit of Dallas residents and visitors.

The FY 2022-23 COP guidelines are consistent with COP guidelines from previous fiscal years; the last major updates to these guidelines were made in FY 2019-20 to align with Dallas Cultural Plan 2018 priorities, including alignment to staff and board diversity goals, and resident panel evaluation of cultural programming in underserved neighborhoods around Dallas.

Updates made in the current proposed guidelines are:

- Program timeline
- Full/part-time staff eligibility requirement clarification
- Funding level restrictions to be a marginal rate based on reported revenue of applicant organization
- Updates to administrative scoring (30 points) including financial reporting requirements, contract compliance, and organizational program management
- Minor wording and document flow updates to improve readability for new applicants, clarify requirements, and update submission deadlines and dates.

COP cultural service contracts are awarded annually using a volunteer review panel approach to evaluate applications. In accordance with Cultural Policy, the panelists are

approved by the Arts and Culture Advisory Commission, and the panels are composed to reflect the diversity of the people of Dallas. Following panel review and scoring, the Allocations Committee of the Arts and Culture Advisory Commission will make recommendations to the full Arts and Culture Advisory Commission. The Commission's funding recommendations will be brought to City Council in the Fall of 2022 for authorization of the associated cultural service contracts.

PRIOR ACTION/REVIEW

On January 6, 2022, the Allocations Committee of the Arts and Culture Advisory Commission voted to recommend these guidelines.

FISCAL INFORMATION

This action has no cost consideration to the City. Appropriations for the Cultural Support Programs are established in the General Fund through the annual budget development process. Each award to a cultural organization through Cultural Organizations Program will be authorized by resolution of the City Council.

We recognize that artistic and cultural expression are fundamental to the development of our identity, as individuals and as a community at large. We assert the right for all people to have access to arts and cultural experiences throughout Dallas.

We recognize the historic legacies of racism, overt bias and injustice that shape our present reality. In fact, the City of Dallas' arts funding originated to support organizations of the Western European canon, collectively referred to as "The Big Six." Going forward, we will strive to support the broadest range of art forms and creative producers, considering inclusivity, diversity and neighborhood impact to direct resources equitably to artists and organizations. We will work to build a robust arts ecosystem that continually evolves to better reflect the diverse composition of Dallas. Towards this end, we recognize and affirm the potential of new and emerging artists and organizations.

The Office of Arts and Culture will serve as convener and connector to catalyze equity in the policies and practices of its partners across the Dallas arts ecosystem. Core to this is leading other organizations and private resource providers to advance diversity, equity and inclusion in concrete, measurable ways. Annually, the Office of Arts and Culture will summarize its own support for artists and arts organizations, highlighting measures of equity and diversity.

As we work together to create a more vibrant Dallas, the Office of Arts and Culture is committed to nurturing the wide diversity of creative culture and experiences that make up this great city.

FY 2022-23 Cultural Organizations Program

The Cultural Organizations Program (COP) is the program through which the City of Dallas Office of Arts and Culture (OAC) provide operational support as described by the Dallas Cultural Policy, approved by City Council on November 28, 2018 [Section 5(D)(i)]. Per the Dallas Cultural Policy, the Office of Arts and Culture contracts for cultural services with established, Dallas-based non-profit organizations for a variety of cultural programs that include concerts, plays, exhibitions, performances, workshops and other cultural programming for the benefit of Dallas residents and visitors. These cultural service contracts are awarded annually using a review panel approach to evaluate applications. Program eligibility and review criteria are published annually.

This document contains guidelines, deadlines and application instructions for the COP managed by the OAC for fiscal year 2022-23. Please refer to the appropriate sections of this guide for more detailed information about the different parts of this program. The FY 2022-23 City of Dallas fiscal year begins October 1, 2022 and ends September 30, 2023.

All applicants are required to read the guidelines and application instructions for details of program eligibility and requirements prior to beginning the application process. Guidelines are updated every funding cycle.

The organization is responsible for the quality, completeness and timely submission of the proposal and supplemental materials. Application steps and deadlines are included in this document and online at dallasculture.org. OAC staff are available to answer additional questions. See Contact OAC.

FY 2022-23 COP Application

All organizations, new and previously funded, are required to complete an application and review process to be considered for funding through the FY 2022-23 Cultural Organizations Program (COP)

The FY 2022-23 COP Application can be found on the COP page of the OAC website at: https://dallasculture.org/cultural-programs/cultural-organizations-program/. Applications must be submitted via the online funding system by April 11, 2022 at 11:59 PM. Hard copies of applications will not be accepted.

NOTE: An organization that submits a substantially incomplete application at the time of the deadline, as deemed by the Office of Arts and Culture, will receive notification via e-mail as to the incomplete status of the application from OAC staff. This could result in the application being rejected.

COP Eligibility Requirements

Organizations must meet the following criteria to qualify for COP funding:

- Must be a 501(c)(3) tax-exempt entity as provided by the U.S. Internal Revenue Code, as amended, in good standing for at least 3 years.
- Must be authorized to transact business in the State of Texas.
- Must be an established City of Dallas arts or cultural organization with an operation history of at least 3 years.
- Organizations must have administrative offices permanently located in the City of Dallas. This does not include P.O.
 Boxes organization must have a physical Dallas administrative office address.
- Must have an annual operating budget of at least \$100,000, based on the organization's prior year's unrestricted revenue. An applying organization must be able to verify most recent completed fiscal year's unrestricted revenue through a Form 990, Form 990-EZ, or third-party financial audit.
- Obtain and maintain during the contract term all necessary licenses, permits, insurance and other approvals required by law for the provision of services.
- Must have at least one paid full- or part-time employee of a Director/Manager level hired upon award of City contract and employed throughout the 12-month contract period. For the purposes of this requirement, an employee is defined as an individual who, through the applicant organization, is paid a regular wage, receives a W-2, and has taxes withheld from those wages. An employee does not include independent contractors.
- Must produce an annual season of programs, exhibitions, and/or performances in the City of Dallas for the public.
- The primary focus of the organization's operation must be to provide services to residents and visitors in the city limits of Dallas and at least 50% of activities must take place within the city limits of Dallas. COP funding may only be used for services provided within the City of Dallas.
- Must be in compliance with local, state, and federal laws prohibiting discrimination.
- Comply with regulations pertaining to federal grant recipients including Title VI of the Civil Rights Act of 1964, Section 504 of the Rehabilitation Act of 1973, the Age Discrimination Act of 1975, the Education Amendments of 1972, the Americans with Disabilities Act of 1990, and the Drug Free Workplace Act of 1988.
- Must have board-approved safe workplace policies (including, but not limited to, anti-discrimination and anti-harassment policies).
- Must have an Equity, Diversity, and Inclusion policy with measurable goals related to equity, diversity and inclusion that are board-approved and published on the organization's website.

COP funds allocated cannot be used to pay direct costs for:

- Activities which do not have a cultural or artistic focus
- Projects planned primarily for fundraising purposes
- Activities restricted to members or which do not benefit the general public

- Tuition expenses
- College/university or school projects that are part of a course or curriculum or which do not benefit the general public
- Fellowships/grants, scholarships, cash prizes or awards
- Activities that include food or alcohol
- Out-of-city travel
- Underwriting of capital expenditures (buildings, land, permanent equipment or artwork)
- Purchase of artwork
- Activities that have occurred prior to the execution of the cultural services contract
- Underwriting of past deficits
- Endowments
- Non-contract related services, lobbying, attorney's fees, fees for penalties, and fees for incorporation or obtaining taxexempt status
- Activities of Dallas-based organizations that occur outside of the City limits
- Permanent or semi-permanent public art that is located on City property

COP Diversity Requirements

Per the Cultural Policy of the City of Dallas, organizations funded through COP should aim to meet the following goals, as set forth in the Cultural Policy. Organizations' progress will be monitored by the OAC on an ongoing basis and OAC staff are available to answer any questions or provide guidance on achieving these goals:

- (1) Have board-approved safe workplace policies (including, but not limited to, anti-discrimination and anti-harassment policies).
- (2) Have a policy and measurable goals related to equity, diversity and inclusion that is board-approved and published on their website.
- (3) Board Diversity¹ goals (by organization budget size):
 - a. Annual operating budget of \$5 million and above: at least 30% board diversity.
 - b. Annual operating budget of \$1 million \$5 million: at least 20% board diversity.
 - c. Annual operating budget of \$500,000 to \$1 million: at least 10% board diversity.
- (4) For organizations with operating budgets over \$1 million: offer paid internships with livable wages to increase the diversity of the pipeline for future arts leaders.

Funding Level Restrictions

A. The limit on support through COP is scaled to be proportional, based on an organization's most recently completed fiscal year's revenue as supported by submitted financial documentation, and in no case shall the amount of funding for an organization through COP be greater than:

- (i) 25% of the applicant organization's revenues up to \$1 million;
- (ii) 15% of the applicant organization's revenues over \$1 million up to \$5 million;
- (iii) and 10% of the applicant organization's revenues greater than \$5 million.

For example, an organization with a documented revenue of \$5,500,000 dollars could receive a maximum of 25% of \$1 million, 15% of \$4 million, and 10% of the remaining \$500,000.

¹ Diversity (as relates to board goals) means the percentage of non-majority (based on race/ethnicity) members of a board. For example, if the goal is at least 30% diversity on a board, an organization meeting that goal must have no more than 70% of any one racial/ethnic group on their board.

- B. Total support by the City in a fiscal year, whether cash or in-kind, regardless of the department from which the funds and support originate, shall not exceed:
 - (i) 50% of an organization's most recent year's audited revenue for organizations with revenue less than \$1 million.
 - (ii) 40% of an organization's most recent year's audited revenue for organizations with revenue of \$1 million or more

C. In- kind support includes, but is not limited to, utility payments made directly by the City, payments made to a third party, including other City departments, in support of the organization, and facility use fee discounts at Cultural Centers.

Source of Cultural Support Funds

The City of Dallas invests in the arts by allocating a portion of the City's general fund (primarily property and sales tax collections) and a portion of Hotel Occupancy Tax (HOT) revenue to eligible applicants who meet the established program criteria and are recommended for funding as a result of an application and review panel process. Per state law, revenue from the municipal Hotel Occupancy Tax collection may be used only to promote tourism and the convention and hotel industry (Texas Tax Code, Chapter 351.101. Use of Tax Revenue)

New Applicants

New applicants are applicants submitting proposals to the program for the first time, as well as to applicants that have applied in the past but are not currently funded through the program.

New applicants must contact OAC staff before the application deadline. This is to ensure that the applicant is aware of the COP requirements and additional information that is needed.

Review Panel & Selection Process

Applications for COP are evaluated by a review panel. The review panel should, to the greatest extent possible, reflect the diversity of the City of Dallas, without sacrificing expertise, knowledge, or demonstrated interest in arts and culture.

Nominations to review panels shall be provided by interested members of the public, the Arts & Culture Advisory Commission, and City staff. In no instance shall a City employee, Arts and Culture Advisory Commissioner, or other City official be a member of a review panel.

Review panel members shall be independent, impartial, and responsible only to the people of the city and shall comply with the Code of Ethics in Chapter 12A of the Dallas City Code including, but not limited to, recusal and disclosure provisions. Panelists should strive to avoid the appearance and risk of impropriety.

Tier Structure

All COP applicants will be reviewed in tier levels based on their unrestricted operating budget from the previous year's official audited records, Form 990, or Form 990 EZ. There will be one review panel for each tier level. The tier levels are as follows:

Tier 1 – \$100,000 – \$499,999

Tier 2 - \$500,000 - \$999,999

Tier 3 - \$1,000,000 - \$4,999,999

Tier 4 – \$5,000,000 or more

Panel Review

In lieu of in-person presentations, each applicant will be required to submit a 10-minute maximum presentational video and attend a 10-minute question and answer session via a web-meeting platform (e.g. Zoom, Microsoft Teams, etc.) with the applicant's respective panel.

Applicants may reference the FY 2022-23 COP Timeline above for a date during which the question-and-answer sessions for each tier will take place. A shorter 30-minute timeslot will be made available to applicants at least a week in advance of the question-and-answer session. During the question-and-answer session, applying organizations must be represented by principal representatives, e.g. the Executive Director, Artistic Director, Board President and/or a Financial Officer or other staff as determined by the organization.

Selection

Review panel and administrative scores are forwarded to the Arts & Culture Advisory Commission for review. The Commission recommends a level of funding for each organization taking into consideration the scoring, prior year funding, funding projections, contract compliance, and fiscal standing of applying organizations. A returning COP organization whose normalized score is below 70% is only eligible to receive a maximum of 60% of their FY 2021-22 COP funding level. A new applicant whose normalized score is below 70% will not be eligible for funding in FY 2022-23. All scores are normalized within their respective tier. Normalizing a score means each score is divided by the highest score of that tier.

The Commission's recommendation is then forwarded to the City Council through the City Manager's Office. The recommended allocation and individual contracts will receive approval or modification by the City Council in October of each year pending City of Dallas budget approval.

Variances from these guidelines may be approved by the Director; however, material variances shall require City Council approval.

Material variances include:

- Changes in tier structure
- Changes in scoring criteria
- Non-profit status requirements
- · Status as a Dallas-based organization or artist
- Changes to ineligible activities

Scoring

Each applicant will be scored on a 100-point scale. Seventy points will be at the discretion of the review panel. The remaining 30 points will be an administrative and compliance score calculated by OAC staff.

Review Panel Scoring

Public Benefit (35 points) – The applicant defines its community in relation to its mission and provides programming that serves its identified audiences and promotes sustainability in the arts and culture sector of the City of Dallas.

Creates unique or meaningful arts and cultural experiences

- Provides inviting opportunities which are accessible to the intended audience
- Meaningfully engages the community to achieve its mission
- Promotes a sustainable arts ecosystem
- Partners with Dallas-based artists or organizations
- Builds meaningful relationships with Dallas residents and community partners

Access & Impact (20 points) – The applicant eliminates barriers and increases equitable access and inclusivity through mission-driven community/neighborhood programming, outreach, and involvement.

- Reflects the values of cultural equity, access, and inclusion through programming
- Invests time, resources, and programming in historically underserved communities
- Elevates and expands neighborhood cultural assets
- Increases creative access, awareness, and appreciation in neighborhoods across Dallas
- Involves, represents, and centers on people and communities most impacted by racism and other forms of discrimination

Organizational Capacity (15 points) – The evaluation of the organization's ability to successfully plan for and manage its proposed services and audience.

- Clarity of application
- Ability to execute and deliver proposed services
- Supplemental materials enhance the overall application
- Clearly defined organizational goals
- Plans to monitor organizational success
- Marketing and communication strategies show an understanding of audiences

OAC Administrative Scoring

Contract Compliance & Financial Viability (10 points) – the organization has shown the capacity to comply with COP monthly reporting and financial report submission requirements that are required by the COP contract (measured from the prior complete fiscal year). The organization has sound financial viability in fundraising/development and unrestricted net assets (measured from the organization's most recent audit).

4 Points: Monthly Reports (returning applicants only)

4 = 10 to 12 reports submitted on time

2 = 7 to 9 reports submitted on time

0 = 6 or fewer reports submitted on time

2 Points: Financial report submitted by deadline (returning applicants only) – the organization has submitted the required financial reporting documentation 180 calendar days (6 months) after the close of the organization's fiscal year. (See table below for financial reporting requirements)

2 = Financial report submitted on time

6 points: Prior Contract Compliance (new applicants only) – The applicant has successfully been recommended for funding and executed at least one contract while maintaining full compliance for ArtsActivate or the Community Artist Program (CAP) in FY 2019-20, FY 2020-21, and FY 2021-22. If an applicant held multiple contracts throughout this time frame, all such contracts must have maintained compliance for full scoring consideration. Final acceptance into FY 2021-22 COP will be contingent upon completion of the terms of the contract amendment and compliance.

- 6 = Recommended for funding and maintained contract compliance
- 0 = Not recommended for funding or did not maintain contract compliance
- **2 Points: Fundraising Expense Percentage** Percentage of sum of fundraising/development expenses to sum of fundraising/development revenues.
 - 2 = Ratio less than 20%
 - 1 = Ratio between 20% and 40%
 - 0 = Ratio more than 40%
- **2 Points: Average Days Cash on Hand** The applicant's average days cash on hand, based most recent Form 990 or Form 990 EZ, calculated by dividing the average of cash and cash equivalents over the year, including savings & temporary investments, by the average monthly expense for the most recent year. Depreciation, depletion, and amortization are excluded from calculation of average monthly expenses.

Form 990 EZ – Average of Line 22A and Line 22B divided by Line 17 minus any non-cash expenses as detailed in Schedule O

Form 990 – Average of Part X, Line 1A plus 2A and Line 1B plus 2B divided Part IX, Line 25A minus Line 22A and any other non-cash expenses

- 2 = 60 days or more cash on hand
- 1 = 30 59 days cash on hand
- 0 = less than 30 days cash on hand

Organization Program Management (10 points) – The organization has performed in a reliable manner in the past in terms of contract sustainability, program management, board governance, and employee compensation.

4 points: SMU DataArts Cultural Data Profile – The organization has completed a Cultural Data Profile (CDP) through SMU DataArts

- Returning applicants are required to complete the three-year history for full point consideration.

 New applicants may complete only a one-year history at the time of submission for the sake of timeliness of submission. The full three-year history must be completed by June 30, 2022, for full point consideration.
 - 4 = Applicant has completed a three-year history CDP
 - 2 = Applicant has completed a one-year history CDP
 - 0 = Applicant has not completed a CDP
- **4 points: Organization Employee Pay** The organization provides sustainability in the Dallas arts ecosystem by providing, at a minimum, a living wage to all full- and part-time employees as aligned with the City of Dallas living wage rate of \$15.21 per hour. These criteria shall only be applied to organizations in Tiers 3 and 4 (revenues \$1 million or more).

2 points: Organization Board Governance – Organization has "give or get" policy with board of directors. In the most recently completed fiscal year, what percentage of board members contributed either by personal donation or securing predetermined funding from a third party for the organization.

2 = 90% - 100% board participation in "give or get" policy

1 = 75% - 89% board participation in "give or get" policy

0 = Less than 75% board participation in "give or get" policy

Adherence to Cultural Policy Diversity Criteria (12 points)

5 points: Board Diversity – Per the City of Dallas Cultural Policy as adopted November 28, 2018, the following goals have been put in place for cultural organizations to demonstrate a commitment to diverse community representation of the organization's board. (Diversity numbers taken from the FY 2022-23 COP Application)

5 points: Staff Diversity – While the Cultural Policy does not set specific goals for staff diversity, the OAC will mirror staff diversity goals based on those of board diversity goals and definitions for the purposes of this scoring category. Staff is considered pay-rolled staff, not contracted labor. Because organizations in Tier I generally do not have significant numbers of staff, they are exempt from staff diversity goals and receive credit for this criterion.

Compliance

COP contracts require compliance for the entirety of the contract period (October 1, 2020 – September 30, 2021). Any major contract compliance issues such as current audits not being received, or other similar items will be presented to the Allocations Committee to recommend a course of action to be taken. This will then be presented to the full Arts and Culture Advisory Commission for recommendation of funding continuation.

To maintain compliance, organizations must provide the following:

Financial Reports

An annual financial report must be submitted to the OAC no later than six months after the completion of the organization's fiscal year. Depending on an organization's operational budget size, the organizations will submit a third-

party financial audit, a Form 990, or a Form 990-EZ (see table below). Failure to meet a financial report submission deadline may result in the withholding of contract payments.

Monthly COP Reports

A monthly report listing Dallas activities and programs presented by the organization, the total attendance at each activity and supporting information must be submitted by the 15th day of each month (reporting the prior month's activities) to OAC.

Final Report

A final evaluation report summarizing activities for the contract period must be submitted to OAC by October 31, 2022. Failure to submit the report in a timely manner or submission of an incomplete report may result in delayed payment or non-payment of the final contract installment as well as payment on future contracts. This online form can be found on the COP page at <u>dallasculture.org</u>.

Business Inclusion and Development: Minority and Women-Owned Business Enterprises

It is the policy of the City of Dallas to use qualified Minority and Women-Owned Business Enterprises (M/WBEs) to the greatest extent feasible on the City's construction, procurement and professional services contracts. The City and its contractors shall not discriminate on the basis of race, color, religion, national origin, age or sex in the award and performance of contracts. In consideration of this policy, the City of Dallas has adopted the Business Inclusion and Development Plan (BID Plan) for all City of Dallas contracts. The purpose of the Business Inclusion and Development Plan is to increase participation of M/WBEs in City procurement and contracting opportunities. And to develop the local business base through the award of contracts and purchases to locally owned businesses. Under the BID Plan, bidders/proposers are required to sign an affidavit agreeing to comply with the City's BID Plan.

The BID Plan shall apply to all City contracts for the procurement of construction, architectural and engineering, goods, other services and professional services, with emphasis on first tier subcontracts on City contracts over \$50,000. As a prerequisite for City Council award, the prime contractor must make a good faith effort to meet established M/WBE subcontracting goals and if goals are not met, must demonstrate and document its good faith effort to meet the established goals.

In addition to the goal-based policy, it is the preference of the City of Dallas for the workforce of contract awardees to be reflective of the diversity of the residents of the City of Dallas.

The City reserves the right to request a company's affirmative action plan or equal opportunity plan from potential contract awardees. In addition, if the potential awardee plans to hire additional staff to complete the contract, the City reserves the right to request a local hiring plan.

Insurance Requirements

Insurance requirements are included in the contract and are determined by the City of Dallas Office of Risk Management. A Certificate of Insurance (COI) must be submitted to the City whenever a policy expires and is renewed. Funds cannot be released without a memorandum of compliance from the Office of Risk Management stating the insurance requirements have been met. Proof of insurance must meet the specific terms of the contract. During the contract term, applicants are

required to obtain and maintain all necessary licenses, permits, insurance and other approvals required by law for the provision of services.

Failure to meet insurance requirements will be reported to the Arts & Culture Advisory Commission and is a default under the contract terms.

Logo and Credit Line

It is imperative that the residents of Dallas know that their local tax dollars make it possible for them to enjoy the caliber of arts produced in this City. All contractors must recognize the City of Dallas in the same way it recognizes other contributors at the same support level in terms of benefits, type size on publications, and frequency of acknowledgment.

Arts organizations and artists awarded City of Dallas contracts for cultural services must include the following reasonably visible and legible credit line and logo in publications, programs, press releases, season brochures, lobby displays, advertising and every other mode of public communication:

"(Name of your organization/program) is supported in part by the City of Dallas Office of Arts and Culture."

Complimentary Tickets

Cultural organizations shall make available up to four complimentary tickets per event, program, production, exhibition or other activity produced by the organization to the OAC for the purpose of allowing City staff to assess the management and operation of City-owned facilities within their jurisdiction and to oversee City sponsored events. This requirement applies to organization's regular programming only and not to special fundraising events. Additionally, the organization may provide free tickets to promotional activities to the Director for distribution to the general public at various OAC facilities.

Receipt of complimentary tickets by City staff is subject to the provisions of the City's Gift Policy For City Employees, provided in Council Resolution 17-0516 adopted on March 22, 2017.

Arts and Culture Advisory Commission Liaison

Funded COP organizations will be assigned a liaison from the Arts and Culture Advisory Commission whose duties will be outlined per organization needs. The liaison assignment will depend on the availability of the Commissioners. COP organizations shall allow attendance by and share minutes with the assigned Arts and Culture Advisory Commission liaison for governing board proceedings, excluding proceedings that are confidential, to the extent allowable by law and board governance.

ALAANA Designation

Applicant organizations are asked to identify as an ALAANA organization if applicable. ALAANA means African, Latinx, Asian, Arab, and Native American. This also includes Native Hawaiian and Pacific Islander (category as defined by the US Census Bureau). An ALAANA organization is one whose primary intentions, practices, and mission are by, for, or about ALAANA artists, cultures, and communities. The word "for" refers to the intention of the organization to perpetuate, promote, and present art that is representative of an ALAANA culture and people and/or is given form by ALAANA artists. ALAANA designation has no impact on funding decisions by the City of Dallas. ALAANA designation has no impact on funding decisions by the City of Dallas, rather it assists OAC in tracking our Dallas Cultural Policy and Plan goals surrounding diversity, equity, inclusion, and access.

Probation

Organizations that fail to provide contractual services or meet program eligibility and reporting requirements may be in default of contract and may be placed on probation per OAC Director discretion. Failure of an organization to satisfactorily address the City's concerns within a period of the probation may result in a recommendation of "no funding" for the next fiscal year.

Revisions

Once the contract has been signed, any changes in the project (either programmatic or financial) must be approved in advance by the Director of the Office of Arts and Culture and will require a formal amendment if it affects the contractual requirements. The contractor must submit a written request for approval of any changes.

SUBJECT

Recommendation in support of Latino Cultural Center Facility Component Naming Rights

BACKGROUND

The City of Dallas Cultural Policy created a policy and process for naming rights on cultural facilities and associated public components under the purview of the Office of Arts and Culture.

In accordance with this policy, the consolidated capital campaign for the Latino Cultural Center Phase II in partnership with Teatro Dallas and Cara Mia generated \$550,500 in donations with the following proposed naming opportunities for public components:

Eliberto Gonzalez Theater (Theater space interior entry way)

Cora Cardona Entrance (Outdoor sign over entrance to new black box theater)

Catalina E. García, MD Walkway (Walkway leading to new theater entrance from Florence

Street)

Friends of the Latino Cultural Center Lobby (Lobby - near the entrance to new theater) The Dallas Foundation Courtyard (New courtyard)

Following Cultural Policy, these names were posted on the OAC and City website for public comment for 30 days beginning on December 15, 2021 (Attachment A). A total of 91 comments were received from 86 individuals, with 81 in favor, 5 general comments, and 0 in opposition to the proposed naming rights. The comments submitted by members of the public are attached (Attachment B).

Of the consolidated capital campaign, \$350,000 has been accepted by City Council, with the remaining \$200,500 scheduled for acceptance in February 2022.

PRIOR ACTION/REVIEW

On November 28, 2018, City Council adopted the Cultural Policy by Resolution No. 18-1683.

On March 25, 2021, City Council accepted a \$100,000 donation from Biscuit Holdings for the Latino Cultural Center by Resolution No. 20-0469.

On August 11, 2021, City Council accepted donations in the amount of \$250,000 from the Communities Foundation of Texas on behalf of various donors to the Latino Cultural Center Phase II Consolidated Capital Campaign by Resolution No. 21-1235.

On October 21, 2021, the Arts and Culture Advisory Commission was briefed on the Latino Cultural Center Phase II and naming rights proposed to date.

On December 6, 2021, the Quality of Life, Arts and Culture Committee of City Council was briefed on the Latino Cultural Center Phase II Update.

History of the Office of Arts and Culture

The City of Dallas' arts and cultural programs were operated through the Parks Department until 1989, when the City Council created the Office of Cultural Affairs, now known as the Office of Arts and Culture (OAC)¹, and the Arts and Culture Advisory Commission. The Office of Arts and Culture is headed by a director who reports to the City Manager. Members of the Arts and Culture Advisory Commission are appointed by the Mayor and City Council.

There are 18 commissioners. Each City Council member appoints one person to the commission, and three additional members serve at large. The Mayor selects the Chair of the Arts and Culture Advisory Commission.

Today the Office of Arts and Culture operates a budget of over \$20 million and has oversight of 19 cultural facilities. OAC employs 75+ people — approximately 50 full time and 30 part-time - dedicated to advancing the arts in Dallas and ensuring that residents and visitors have access to a broad array of arts and cultural opportunities.

Members of Arts and Culture Advisory Commission

The Arts and Culture Advisory Commission is an advisory body to the City Manager and City Council in accordance with Section 8-26 of the Dallas City Code.

- The Commission's main objectives are to make recommendations regarding City of Dallas cultural policies and participate in funding decisions for programs, facilities and organizations.
- Commissioners are periodically asked to review and vote on major projects before they are considered by the City Council.
- The Commission also recommends new ways for citizens to have access to the arts and the means of cultural expression.

¹ The name of the Office of Cultural Affairs was changed to Office of Arts and Culture as of October 1, 2019 by City Council Ordinance 31333.

- Commissioners serve as ex-officio non-voting liaisons on the governing boards of some institutions funded through the Cultural Organizations Program.
- The Commission works with the City of Dallas Office of Arts and Culture, a city department, in the implementation of the Cultural Policy and its programs.

- (1) Develop, implement, administer and promote programs or initiatives that support its mission and that reflect its commitment to cultural equity as well as the City of Dallas's core values of empathy, ethics, excellence, and equity.
- (2) Provide equitable access to artistic and cultural experiences that meet individual and community needs for residents across the city.
- (3) Recognize, honor, and celebrate the full breadth of Dallas' and Dallas residents' rich cultures and creative expression; these cultures and creative expression must flourish at all times in a democratic society.
- (4) Partner with artists, organizations, funders, and other government agencies to dissolve boundaries, promote better human relationships, build a sense of community, reduce conflict, encourage cooperation and promote harmony.
- (5) Understand and meet the needs of historically marginalized groups and individuals, including children, artists and organizations from ALAANA and

LGBTQIA+ identities, those with disabilities, immigrants regardless of citizen status, and those who are socioeconomically disadvantaged.

To accomplish this, the Office of Arts and Culture will strive to:

- (1) Work in partnership with artists, organizations, the public, the Arts and Culture Advisory Commission, and City Council to continuously improve policies, procedures and programs in recognition that the work is never done.
- (2) Advocate for the necessary capital and operating resources within the City of Dallas to accomplish its mission.
- (3) Encourage collaborations, communication, and community building between and among arts and cultural groups and artists, as well as connections to educational institutions, civic organizations, public agencies and private enterprises.
- (4) Ensure that the perspective of arts and culture and artists is integrated into the planning and operations of relevant City of Dallas groups and services.
- (5) Network among and convene artists, arts and cultural organizations, partners, and funders to build community, enhance communication, and work together to promote the sector as a whole and grow together as an ecosystem.
- (6) Establish a long-range plan that proactively addresses and funds capital and operating needs of City-owned facilities, and periodically review or revise the plan, including a full review of the Cultural Policy every five years and a full review of the Cultural Plan in no more than ten years.

(The Vision, Mission and Guiding Principles were in the City of Dallas Cultural Policy unanimously adopted by City Council on November 28, 2018.)

Program and Committee Structure

Standing and Ad Hoc Committees of the Arts and Culture Advisory Commission

- <u>Allocations</u> Standing. Meets regularly to review panel recommendations on funding for artists and organizations. Makes recommendations to full Commission. The Chair of Allocations as of September 30, 2021, was Ella Goode Johnson from District 3.
- <u>Public Art</u> Standing. Meets regularly regarding maintenance and preservation of city-owned art. Makes recommendations about new projects, from initiation, through artist selection and contracting through completion. The Chair of the Public Art Committee as of September 30, 2021, was Grady McGahan, an at-large commissioner.

Task Force(s) of the Arts and Culture Advisory Commission

<u>Dallas Cultural Plan Task Force</u> – Ad Hoc. Met to develop recommendations regarding the implementation of the Dallas Cultural Plan, with input on the annual community report-out in November 2020.

Programs

Cultural Services Contracts: (31.4% of OAC General Fund Expense Budget) The
City contracts for services with Dallas nonprofit cultural organizations and
individual artists to support a wide variety of arts and cultural programs,
including concerts, plays, exhibitions, lectures, workshops and festivals. Cultural
Services are procured through three main programs: Cultural Organizations
Program, ArtsActivate 2021, and Community Artist Program.

In addition, two pilot grant programs were created and run in FY 2020-21: Culture of Value for artists and organizations, and a Non-Profit Residency Program through Community Arts Division. Culture of Value was created to support projects by and rapid relief to ALAANA artists and organizations during the COVID-19 pandemic, using project micro-grants up to \$3,000. Funding for this program was through the Arts Endowment Fund. The Non-Profit Residency

Program was piloted with five ALAANA organizations (who were not currently in COP) to provide longer-term services, or residencies, in City Council Districts where there is not a City Cultural Center. These five awards of \$20,000 each were funded through the "pop-up" Community Arts Budget.

• Cultural Venues: (66.8% of OAC General Fund Expense Budget) The City operates six cultural facilities that provide professional quality space for the performance and presentation of arts and cultural events. These facilities include the Bath House Cultural Center, Oak Cliff Cultural Center, Latino Cultural Center, South Dallas Cultural Center, Majestic Theater and Moody Performance Hall. The City also operates the Juanita Craft Civil Rights House which is currently under renovations and closed to the public.

Additionally, the Office of Arts and Culture manages eight long-term use and management agreements with nonprofit cultural organizations for the operations and programming of city-owned cultural facilities, including the AT&T Performing Arts Center (Winspear Opera House, Wyly Theater and Annette Strauss Square); The Black Academy of Arts and Letters (at the Kay Bailey Hutchison Convention Center Dallas); Dallas Black Dance Theater (Moreland YMCA); Dallas Heritage Village at Old City Park; Dallas Theater Center (Kalita Humphreys Theater and Heldt Administration Building at Kalita Humphreys Theater); Dallas Museum of Art; Dallas Symphony Association (Meyerson Symphony Center); and Sammons Center for the Arts.

On May 26, 2021, City Council approved a 40-year development agreement with the Sammons Center for the Arts for development of an arts incubator at 3111 North Stemmons Freeway in Council District 6; this development is colloquially referred to as the Commonwealth Development or Sammons II.

• Public Art Program: (1.8% of OAC General Fund Expense Budget) The Commission reviews ongoing projects in the Public Art Program in conjunction with the Public Art Committee. The Commission and Public Art Committee work with City staff to review and recommend project funding through the bond programs and to review and approve donations of public art to the City of Dallas. The mission of the Public Art Program is to enrich the community through the integration of the vision and work of artists into the planning, design and

construction of public spaces. The Public Art Program is a commitment by the City to invest in art across neighborhoods and creates new opportunities for artists and the arts to connect with communities and other City departments. Through this program, the community can see themselves in new ways as they work alongside the City and the artists to create artwork for current and future generations.

• **Municipal Radio:** The Office of Arts and Culture provides oversight for WRR Radio, a City-owned commercial radio station that broadcasts classical music to the DFW region. WRR operates as an enterprise fund of the City of Dallas.

Major Accomplishments

The Metrics Chart below provides highlights of OAC's work. A more detailed listing of grants and facilities is appended at the end of the document.

Cultural Services Contracts

The Commission's funding recommendations for Fiscal Year 2020-21 included \$5,091,121 to 36 organizations through the Cultural Organizations Program; \$286,500 to 36 projects proposed by artists and organizations through ArtsActivate 2021²; and \$409,000 to support performances, workshops, and other community events with 44 artists and organizations through the Community Artists Program.

_

² Due to COVID-19 and related restrictions, many ArtsActivate 2020 projects were postponed until restrictions were lifted, or programming adjustments could be made to accommodate health and safety protocols. This resulted in contract amendments and executions to extend service deliveries to extend through FY 2020-21 (October 1, 2020 – September 30, 2021). The total FY 2020-21 ArtsActivate budget was \$600,000 for ArtsActivate 2020 extensions and new ArtsActivate 2021 contracts.

- The Commission also recommended \$208,860 in funding to 71 ALAANA artists and organizations from the Arts Endowment³ through the Culture of Value pilot, and 5 ALAANA arts organizations were awarded \$100,000 for the pilot Non-Profit Residency Program to create longer-term programming in 10 locations across Dallas.
- The Commission also recommended annual funding program guidelines that allowed for all-virtual panels and Spanish language applications.

Public Art Program

The Arts and Culture Advisory Commission appointed members to the Public Art Committee. The Commission, based in part on input from the Public Art Committee, provided recommendations related to public art projects throughout the year. Projects included public art commissions or donations at the following locations:

- Bath House Cultural Center (Council District 9)
- Watercrest Park (Council District 10)
- Victory Overlook on the Katy Trail (Council District 2)
- Memorial for Victims of Racial Violence at Martyr's Park (Council District 2)
- Crockett Dog Park (Council District 2)
- Twin Falls Park (Council District 3)
- Lemmon Avenue Streetscape (Council District 13)

In addition, the Public Art Committee and Arts and Culture Advisory Commission recommended revised assessment criteria for Public Art depicting individuals or representing organizations in the City of Dallas Public Art Collection and recommended the deaccession of the Public Art mural at the Jefferson Street Viaduct in Council District 1.

³ The Arts Endowment was established by Council Resolution No. 84-31 in 1984 for the purpose of providing supplemental financing to the City's current funding for existing and emerging arts institutions; all available Council appropriations for earned interest were made available for the Culture of Value program in FY 2020-21.

The Public Art Program had the following successes in recognition, education, and outreach:

- Love Field Art Program conducted (12) tours with a total of (158) people
- Love Field Art Program created a 360 Virtual Art Tour Link Here
- Love Field created an animated cartoon with (8) of pieces designed for kids that airs in our Lil' Love Lounge Children's Play area Link Here
- Began partnership with the Consul General of Canada to develop an augmented reality public art project with a Dallas-based artist and Canadian indigenous artists. This project is funded and sponsored by the Consul General of Canada

In February 2021, a severe winter storm impacted Dallas and was declared a major disaster by President Joe Biden. Among other impacts on residents and property, pipes at the Hall of State at Fair Park froze and subsequently burst. Twenty-two (22) artworks in the City of Dallas Public Art collection were damaged by the water from burst pipes, and emergency conservation was undertaken to conserve and restore the works. The works are listed below:

- 18 large photographs printed on large glass plates, known as orotones, by artist Polly Smith that were commissioned in 1935 as part of the Texas Centennial
- Four murals created in 1936 by artists Olin Hermann Travis, Arthur Starr Niendorff, and Tom Lea. Of the four murals, one is a fresco and three are oil on canvas.

Public Art began the appraisal process for the whole collection, starting with murals and bas reliefs at Fair Park; the last appraisals for Fair Park art were done in 2000. The Pegasus figure at the Magnolia Hotel stabilization and repair was initiated in September 2021, and work on the Hall of Negro Life film project advanced with the creation of an oral history archive and the promotional sizzle reel.

Other Accomplishments & Recommendations

• The Arts and Culture Advisory Commission supported development of the Culture of Value micro-grant program for ALAANA (African, Latinx, Asian, Arab, and Native American) artists and organizations.

- Due to the COVID-19 pandemic restrictions, the Office of Arts and Culture's cultural venues were shuttered through April 2021. Slowly, they began to reopen with protocols in place to protect staff and patrons. By June 2021, OAC staff had resumed onsite work for more than 50% of the week. By September 2021, all venues were reopened and the large venues (Moody Performance Hall and Majestic Theatre) were back at full capacity.
- The Office of Arts and Culture administered \$1.698M in federal Coronavirus Aid, Relief, and Economic Security (CARES) funding to upgrade and equip City-owned and other privately-owned cultural venues for safer COVID-era cultural experiences. Of the total, \$1.510M was administered with partners, with the remaining amount used to equip City-owned, City-managed cultural facilities including the Majestic Theater, Moody Performance Hall, and the four neighborhood cultural centers for safer COVID-era cultural experiences.
- The Arts and Culture Advisory Commission supported the work of the Office of Arts and Culture staff in the preparation of budget bids for FY 2021-22 and FY 2022-23.
- The cultural centers and performance venues experienced minimal damage from the severe winter storm that impacted Dallas in February 2021. The facilities did not go without power, but some did sustain water damage from leaking pipes and air handler units which caused some minor interior damage. As of November 2021, work is currently underway to remediate these issues.
- The Arts and Culture Advisory Commission was briefed on the transition of responsibility for paying Fair Park organizations (cultural services contracts for Dallas Historical Society, African American Museum and utilities/operating reimbursements for Dallas Summer Musicals) back to the City and Office of Arts and Culture from Fair Park First.
- The Office of Arts and Culture invested in capacity building in partnership with local arts organization TeCo Theatrical Productions, d/b/a Bishop Arts Theatre Center to offer three workshops for arts organizations about: Board Development/Leadership, Risk Management, and Fundraising Strategies.

- The Office of Arts and Culture and partners celebrated the Centennial of the Majestic Theatre with a documentary which aired several times on KERA, a Community Day and historical exhibit opening, a Gala Dinner that raised more than \$90,000 to increase access to the Majestic for local arts nonprofits, the formation of a Friends group, and plans for upcoming Gala Concert in April 2022.
- A third officially recognized cultural district by the Texas Commission on the Arts in Fair Park/South Dallas. This includes the COP-supported organizations within Fair Park and the South Dallas Cultural Center and Juanita J. Craft Civil Rights House and Museum. This brings the total number of officially recognized cultural districts in Dallas to three.
- The Office of Arts and Culture was awarded grants and recognition from the following organizations:
 - U.S. Small Business Administration Shuttered Venue Operator grants in the amount of \$1,077,461 for pandemic-related expenses for the Majestic Theater (\$754,895), Moody Performance Hall (\$295,687), and Latino Cultural Center (\$26,879).
- OAC Director Jennifer Scripps was selected by D Magazine as one of "78 Women Who Make Dallas Great" in September 2021.
- City Council accepted donations and grants for the Juanita J. Craft Civil Rights House and Museum totaling \$355,000 from the following donors:
 - \$250,000 from the Communities Foundation of Texas for funds raised in partnership with the Junior League of Dallas for their Centennial Anniversary Project from the Hoblitzelle Foundation (\$100,000.00), Eugene McDermott Foundation (\$100,000.00), the Addy Foundation (\$20,000.00) Summerfield Foundation (\$10,000.00), Children's Medical Center Foundation (\$10,000.00), and the Junior League Garden Committee (\$10,000.00)
 - \$50,000 from the Hillcrest Foundation
 - \$50,000 from the Summerlee Foundation

- \$5,000 from the W.P. & Bulah Luse Foundation
- City Council accepted grants for the Latino Cultural Center Consolidated Capital Campaign with Resident Companies Teatro Dallas and Cara Mia Theatre Company totaling \$250,000 from the Communities Foundation of Texas on behalf of the following donors: Cara Mia Theatre Company Board of Directors (\$100,000.00), Dr. Catalina Garcia (\$50,000.00), and anonymous donors (\$100,000.00).
- City Council accepted matching donations for the National Park Service for the Hall of Negro Life project totaling \$17,500 from Inspire Art Dallas (\$10,000) and Fair Park First (\$7,500).

Goals for the Coming Year

- The Commission will continue to monitor and advise as to the ongoing implementation of the Dallas Cultural Plan.
- The Commission will advance goals related to support of small and emergent arts groups, including implementation of artist residencies, nonprofit artist residencies, Culture of Value grants and the first Dallas Poet Laureate in partnership with the Dallas Public Library and Deep Vellum Publishing.
- The Commission will support the Office of Arts and Culture in the City budget process for FY 2022-23 and 2023-24.
- The Commission will support revitalized Arts Month activities in April 2022.
- The Commission will be briefed on Facilities and Bond Project progress, including the re-opening of the Juanita J Craft Civil Rights House and Museum and the grand opening of the Latino Cultural Center Phase II.
- The Commission will support the DMA's strategic planning process. This work will impact the City of Dallas' lease and long-term capital investment plans in advance of future bond programs.
- The Commission will be briefed on virtual and neighborhood access to arts and cultural experiences through OAC programs and partner services.

The City operates six cultural centers that provide professional quality space for the performance and presentation of arts and cultural events as well as the Juanita Craft Civil Rights House and Museum. These facilities include:

- Bath House Cultural Center (BHCC) 521 E. Lawther Drive, Dallas, TX 75218. The Bath House is typically open Tuesday through Saturday from 12 pm to 6 pm and closed on Sunday and Monday. The Bath House is typically open until 10 pm on nights with theater performances and open on Sundays during special events. Please check calendar of events for special event dates. Located on the shores of beautiful White Rock Lake, the Bath House Cultural Center is a welcoming venue for visual and performing artists from an array of backgrounds. The historic, art deco style Bath House houses a 120-seat black-box theater, two gallery spaces, the White Rock Lake Museum, and a number of multipurpose spaces.
- Juanita Craft Civil Rights House 218 Warren Ave., Dallas, TX 75215. The 900-sq. ft. one-story frame house was the home of Juanita Craft, one of Dallas' most significant civil rights figures and the second African American woman to serve on the Dallas City Council. Programming at the Juanita Craft Civil Rights House is coordinated by the South Dallas Cultural Center.
- Moody Performance Hall 2520 Flora St., Dallas, TX 75201. The Moody Performance Hall is a multi-disciplinary center that will bring to the Dallas Arts District a broad range of cultural performances and events by a growing group of small and midsize cultural organizations that represent all artistic disciplines and the diverse heritages of our community. Located at the intersection of Routh and Flora, the Moody Performance Hall will be a gateway to the Arts District.
- Latino Cultural Center (LCC)- 2600 Live Oak St., Dallas TX 75204 The Latino Cultural Center is typically open Tuesday through Saturday from 10 am to 5 pm and is closed on Sunday and Monday. The Latino Cultural Center (LCC) was designed by world-renowned architect Ricardo Legorreta and dedicated on September 16, 2003. A multidisciplinary arts center that presents Latino artists in the visual and performing arts, film, and literature, the LCC also supports local artists and arts organizations by developing and celebrating Latino art and culture. As of 2021, the LCC is home to two resident theater companies, Teatro Dallas and Cara Mia.
- Oak Cliff Cultural Center (OC3)- 223 W. Jefferson Blvd., Dallas, TX 75208. The Oak Cliff Cultural Center is typically open
 Tuesday through Friday from 3:00 PM to 9:00 PM, and on Saturdays from 10:00 AM to 6:00 PM. The Oak Cliff Cultural
 Center provides community-based arts and cultural programming for the North Oak Cliff and West Dallas communities. The
 Center provides a wide variety of art exhibitions, artist workshops, art, music, and dance classes, and cultural festivals for
 both children and adults, creating an environment for artists and students to learn and experience the creative powers of
 the arts.
- South Dallas Cultural Center (SDCC) 3400 South Fitzhugh, Dallas, TX 75210. The South Dallas Cultural Center became a reality through the efforts of key individuals in the African-American community, who encouraged the City of Dallas to develop a multi-purpose arts facility in South Dallas. Under the leadership of City officials and Park Board members, funds were allocated through the 1982 bond program to construct the \$1.5 million, 24,000 square-foot facility, located across from Fair Park.
- Majestic Theatre 1925 Elm Street, Dallas, TX 75201 One of the most elegant and historic performing arts spaces in the Southwest, the historic Majestic Theatre is managed by the City of Dallas Office of Arts and Culture. Built in 1921, the Majestic hosts a variety of concerts, performing arts, comedy and corporate events through the year presented by national and local artists, promoters and nonprofit arts organizations.

Additionally, the Office of Arts and Culture manages 9 long-term use and management agreements with nonprofit cultural organizations for the operations and programming of city-owned cultural facilities, including:

- The AT&T Performing Arts Center Margo and Bill Winspear Opera House 2403 Flora Street, Dallas, TX 75201. One of the four venues of the AT&T Performing Arts Center in the Dallas Arts District, the Winspear Opera House was designed by Pritzker Prize winning architect Norman Foster and Foster + Partners. The 2,200-seat hall opened in October 2009. The Winspear is the home of The Dallas Opera, Texas Ballet Theater, a Broadway series, and other local and international performing arts presentations. Dee and Charles Wyly Theater 2400 Flora Street, Dallas, TX 75201. One of the four venues of the AT&T Performing Arts Center in the Dallas Arts District, the Wyly Theatre was designed by REX/OMA, Joshua Prince-Ramus (partner in charge) and Pritzker Prize-winning architect Rem Koolhaas. The 575-seat theatre opened in October 2009. The Wyly is the home of the Dallas Theatre Center, Dallas Black Dance Theatre, and Anita N. Martinez Ballet Folklorico. Annette Strauss Square 2389 Flora Street, Dallas, TX 75201. One of the four venues of the AT&T Performing Arts Center in the Dallas Arts District, Strauss Square was designed by the internationally renowned firm Foster + Partners. Strauss Square was dedicated in September 2010 and hosts a variety of outdoor events ranging from concerts to theatrical and dance performances to multi-day festivals, accommodating audiences of up to 2,000 in a serene open-air setting. Elaine D. and Charles A. Sammons Park 2403 Flora St, Dallas, TX 75021. One of the four venues of the AT&T Performing Arts Center in the Dallas Arts District, this 10-acre park was designed by landscape architect Michel Desvigne of Paris in collaboration with JJR of Chicago. Sammons Performance Park opened in October 2009.
- The Black Academy of Arts and Letters (at the Dallas Convention Center) 1309 Canton Street, Dallas, TX 75201. Housed in the original 1957 section of the Dallas Convention Center that was designed by noted Dallas architect George Dahl, TBAAL has an 1,800-seat theater and a 250-seat café theater, plus gallery, gift shop, meeting rooms and administrative and support spaces.
- Dallas Black Dance Theater (Moorland YMCA) 2700 Ann Williams Way, Dallas, TX 75201. Built in 1930 as the city's only YMCA for the African-American community, the 32,000-sq. ft. building was designed by Dallas architects Ralph Bryan and Walter Sharp. It served as a YMCA until 1970, when a new facility was built in Oak Cliff and the historic building was acquired by the private sector. Dallas Black Dance Theatre purchased the building in 1999 and in 2005 transferred the deed to the City of Dallas as part of a public/private partnership to renovate the facility. After an extensive renovation, the building reopened in 2008 as the Arts District home of Dallas Black Dance Theatre.
- Dallas Heritage Village at Old City Park 1515 S. Harwood, Dallas, TX 75215-1273. This 13-acre village is a living history museum portraying life in North Texas from 1840-1910. Located in what was Dallas' first public park, the 38 historic structures on the site have been relocated from sites around North Texas. The facility is managed by the Dallas County Heritage Society.
- Dallas Theater Center (Kalita Humphreys Theater and Heldt Administration Building at Kalita Humphreys Theater) 3636 Turtle Creek, Dallas, TX 75219. The 33,000-sq. ft. theater was designed by American architectural legend Frank Lloyd Wright and is the only stand-alone theater designed by Wright that was built. It was built by the Dallas Theater Center in 1959 and transferred to City ownership in the 1970s. The Kalita has been in continuous operation since 1959 as the home of the Dallas Theater Center. The 33,000-sq. ft. facility provides office, rehearsal and costume shop space to support the theatrical activities at the Kalita Humphreys Theater. The Heldt was designed by Dallas architect Art Rogers and completed in 1990.
- Dallas Museum of Art 1717 North Harwood, Dallas TX 75201. The 528,000-sq. ft. facility was designed by AIA Gold Medal recipient Edward Larrabee Barnes. The building anchors the Dallas Arts District's western side and first opened in 1984, with a subsequent addition opening in 1993. The facility was funded through a public/private partnership between the City of Dallas and the Dallas Museum of Art, a nonprofit corporation.
- Dallas Symphony Association (Morton H. Meyerson Symphony Center) 2301 Flora, Dallas, TX 75201. The 485,000-sq. ft. facility was designed by Pritzker Prize recipient I.M. Pei. This building is home to the Dallas Symphony Orchestra, which took over long-term management and operations of the building in 2019. The facility was funded through a public/private partnership between the City of Dallas and the Dallas Symphony Association, a nonprofit corporation.

- Sammons Center for the Arts (Historic Turtle Creek Pump Station) 3630 Harry Hines Blvd., Dallas, TX 75219. This historic landmark began its life in 1909 as the Dallas Water Utilities Turtle Creek Pump Station. In 1981, through the efforts of the cultural community, it was renovated through a public/private partnership into the Sammons Center for the Arts.
- Commonwealth Development with Sammons Center for the Arts 3111 North Stemmons Freeway, Dallas, TX 75247. This lot of 3.7 acres of City-owned land has been leased in a 40-year development agreement to the Sammons Center for the Arts for a new arts incubator to be built. City Council approved the development agreement in May 2021.

CULTURAL SERVICES CONTRACTS

The City contracts for services with Dallas nonprofit cultural organizations and individual artists to support a wide variety of arts and cultural programs, including concerts, plays, exhibitions, lectures, workshops and festivals. Cultural Services are procured through three main categories: Cultural Organizations Program, ArtsActivate 2021 and Community Artist Program. In FY 2020-21, two pilots were created: the Culture of Value relief program for ALAANA artists and non-profit cultural organizations, and the Community Arts Non-Profit Residency program.

Note: Descriptions are taken from artist and organization application/website materials; typos and tone differences may occur due to this varied sourcing.

Cultural Organizations Program (COP)

The **largest** of the Cultural Services Contracts programs, COP is the program used to contract for cultural services with established non-profit cultural organizations to support an array of programs that include concerts, plays, exhibitions, performances, workshops, and other cultural services. These contracts are awarded annually using a best practice, peer review panel approach to evaluate applications.

Program eligibility and review criteria are published annually. An organization receiving a COP contract was eligible to apply for project-based funding through ArtsActivate 2021, provided that it met the eligibility requirements. The maximum amount any one organization can receive through COP is 25% of their prior year audited expenses (the current average is under 10%).

The Arts and Culture Advisory Commission appoints the panels and reviews the panel ratings to make funding recommendations. The Commission's recommendations, in turn, form the basis of the contracts that are brought forth to City Council for approval.

In 2020-2021 there were 36 organizations in the Cultural Organization's Program and included \$5,091,121 in funding. In June 2021, African American Museum and Dallas Historical Society returned to COP after having been under a previous agreement with Fair Park First. All figures below reflect this addition.

ArtsActivate 2021

ArtsActivate 2021 provided funding for projects from eligible non-profit arts/cultural organizations, individual artists, and artist collectives.

In FY 2020-21 there were 36 projects recommended by the Allocations Committee of the Arts and Culture Advisory Commission through one round for artists and organizations totaling \$286,500 in recommended amounts. FY 2020-21 was the first year that ArtsActivate applications were accepted in Spanish for Spanish language applicants. In the list below, "*" denotes a Spanish language applicant.

Due to COVID-19 and related restrictions, many ArtsActivate 2020 projects with original deadlines before October 1, 2021 were extended through amendents or delayed contract executions through FY 2020-21 (October 1, 2020 – September 30, 2021). A total of 53 projects totaling \$289,520 in funding were part of this extension from FY 2019-20. Details on ArtsActivate 2020 projects can be found in the FY 2019-20 Commission Annual Report.

Culture of Value funded a total of 71 projects recommended through two rounds for artists and organizations totaling \$208,860 in recommended amounts. Culture of Value was also the program used to pilot applications in Spanish for Spanish language applicants to have access to apply. In the list below, "*" denotes a Spanish language applicant.

Public Art Program

The Commission reviews ongoing projects in the Public Art Program in conjunction with the Public Art Committee. The Commission and Public Art Committee work with City staff to review and recommend project funding through the bond programs and to review and approve donations of public art to the City of Dallas. The mission of the public art program is to enrich the community through the integration of the vision and work of artists into the planning, design and construction of public spaces. The Public Art Program is a commitment by the City to invest in art across neighborhoods and creates new opportunities for artists and the arts to connect with communities and other City departments. Through this program, the community can see themselves in new ways as they work alongside the City and the artists to create an artwork for current and future generations.

The Arts and Culture Advisory Commission, along with input from the Public Art Committee, provided recommendations related to new public art projects throughout the year. Recommendations included:



Coronavirus Aid, Relief, and Economic Security (CARES) Act 2020 contracts with cultural partners for safer cultural experiences

In FY 2020-21 there were 20 organizations approved by City Council for CARES reimbursement contracts totaling \$1,510,248.52 for expenditure of the funds in accordance with Federal guidelines for the acquisition and distribution of medical and protective supplies, including sanitizing products and personal protective equipment for the safety of staff and patrons in connection with the COVID-19 public health emergency.

OAC partners were initially provided with \$1 million, approved by City Council in September 2021; this initial round of contracts was with the seven organizations that manage City-owned facilities under OAC's authority, which are marked below with an asterisk (*). Allocations were based on \$75,000 for up to 100,000 square feet, and an additional \$50,000 per additional 100,000 square feet thereafter. Kalita Humphreys Theater received \$50,000 due to limited use and budget constraints.

Following additional budget availability from the City's CARES allocation, 13 additional partners were approved by City Council for awards based on 25% of the FY 2020-2021 COP contract award, or \$50,000.00 for cultural venues with a footprint of over 50,000 square feet or more. The organizations then submitted budgets to Office of Art and Culture for qualified expenses to ensure ability to spend by the deadline for CARES funding.
