On February 8, 2022, Ms. Nikita Sutton requested that the CPOB review her complaint at its March 8, 2022, board meeting. In preparation for the Board's discussion, the OCPO Director provided Board members with case information regarding Nikita Sutton's complaint.

At the March 8, 2022, Board meeting, CPOB Chairman Enobakhare, Jr. requested that the review of this complaint investigation be tabled until the April 2022 meeting to give CPOB members a chance to thoroughly review the matter. A vote was made and passed unanimously to table the matter.

At the April 19, 2022, Board meeting, OCPO Special Investigator K.A. Williams will give the Board a brief synopsis of Ms. Sutton's case. After that Chairman Enobakhare, Jr. will lead the Board in a dissuasion about the complaint investigation. At the conclusion of the discussion, the Board will be asked to vote on this matter. You will decide if you want OCPO to do an independent investigation or if no further action is needed.

Synopsis of Incident: Ms. Nikita Sutton alleges that she and her son (a juvenile) were racially profiled by Officers Smith #9089 and Moon #11927. Additionally, that Officer Smith was rude/discourteous. "I'm filing a complaint due to the incompetence, impulsive aggressive behavior, racially motivated officers that appeared on the scene". The complainant disputes the outcome and final decision of her complaint. Ms. Nikita Sutton states, "I received a letter stating that my report was dismissed. I Implore you to reconsider, taking it so lightly. The officer may not have seen anything wrong with his behavior., However, if you do not see anything wrong with a man of the law addressing a minor with so much aggression and callousness then I questioned the DPD in their abilities to keep us safe". *Please see DPD citizens complaint review form statement.*

Allegation: Discourtesy / Unprofessionalism / Racial Profiling

DPD Investigation Summary: No Investigation: No DPD policy violations.

Part B: OCPO Position:

OCPO disagreed with the IAD decision. OCPO feels that the case should have been a division referral for discourtesy and unprofessionalism based on the way the officers approached Ms. Sutton when they arrive at the scene.

The level of aggression towards Ms. Sutton and how their voices were elevated from the moment the officers approached her was unnecessary given the totality of the circumstances.

Even if the tow truck's driver's account of how Ms. Sutton was behaving towards him and his cameraman was true, Ms. Sutton had clearly calmed down by the time DPD arrived. So, their level of aggression towards her and their demeanor was unwarranted.

Investigational Review: On January 11, 2022, the Community Police Oversight Board voted to have the Office of Community Police Oversight investigate Mr. Samuel B. Hafertepe's cases.

Office of Community Police Oversight: Special Investigator K.A. Williams conducted an investigation of Mr. Hafertepe's cases.

Synopsis of Incidents: Mr. Hafertepe has a total of 13 complaints; the synopsis of each case as well as, DPD's investigation case summaries, and OCPC investigative findings and recommendations are below.

Documents Reviewed in the Investigation: DPD Officer's Body-Worn Camera footage, DPD reports, officer's statements, complainant statements and 911 call recording.

Case #1

There are 6 cases that DPD duplicated to each other for record purposes because the complaints were the same or very similar. Based on the totality of allegations, the case was sent as a Division Referral to the Southeast Patrol Division to investigate the matter.

A) **DR2021-058** (**EC2021-0394**) Complainant alleges Detective Koerner only issued a misdemeanor citation to the suspected person instead of a felony based on the fact that Mr. Hafertepe is "legally blind". Also, Detective Koerner did no investigation or follow-up or follow-up on the case.

Involved Officer: Senior Corporal Derek Walter Koerner #9169

Complainant Statement. Hafertepe alleged that Detective Koerner issued a citation to a suspect for assaulting him. Mr. Hafertepe stated that he is legally blind and believes that the assault should be a felony. Mr. Hafertepe believes Detective Koerner gave the wrong person a citation for assaulting him.

DPD IAD DR Summary: The complaint filed against a member of the Dallas Police Department has been investigated by their chain of command. The investigation was unable to establish a violation of departmental policies based on a preponderance of the evidence.

Reviewed by Police Major Gerald D Smalley #6233 on June 1, 2021, at 12:27. Decision: Approved. Comments/Response from Police Major Gerald Smalley: "Unfounded."

OCPO Investigative Findings: OCPO in its review of officer's body worn camera footage Mr. Hafertepe can be seen describing the incident in detail to officers. Answering questions by officers as to the shape, size, and color of the instrument that was thrown at him. Officer Quevedo asks Mr. Hafertepe "where did he hit you?" Mr. Hafertepe starts to roll up his pants leg to show officers his injury. Then States "the pipe barely grazed my leg", then Officer Quevedo ask "are you in pain?" Mr. Hafertepe says "no". BWC confirms Mr. Hafertepe said he felt no pain and was barely touched by the object that hit his leg, making the offense a Class C Assault - Offensive Contact. OCPO agrees with IAD's findings as **Unfounded.**

The other cases related to the Division Referral are listed and described below:

B) EC2021-0223: Mr. Hafertepe alleges responding officer's CSRU end supervisor failed to investigate thoroughly and took improper or no action.

OCPO Investigative Findings: During its investigation, OCPO confirms that on March 31, 2021, Mr. Hafertepe's 911 call was received, and officers were dispatched to his residence. The officers dispatched were approaching the complaint, who stated in his 911 call that he had a gun. Once officers arrived their body worn camera footage showed officers providing service in a professional manner, gathering information as to what happened to Mr. Hafertepe.



On officers BWC Mr. Hafertepe explained in detail what happened to him. Once officers at the scene received and recorded all information, officers then heard a car accident in the proximity of where they were. Officers left Mr. Hafertepe's situation to service the car accident. DPD officers later returned to find the person in question that allegedly assaulted. Mr. Hafertepe. This person Terry Willingham. Mr. Willingham was found and cited by officers on March 31, 2021, at 4:26 pm. The citation was for assault (contact) P.C.22.01 (A) (3).

OCPO finds Mr. Hafertepe's allegation **Unfounded**. Officers' actions are cleared by body worn camara footage.

C) **EC2021-0366:** Mr. Hafertepe alleges the officers failed to fully investigate the call by not contacting the suspect who had assaulted him. Officers also failed to document that he is legally blind and disabled. The person of interest in Mr. Hafertepe's alleged assault was later given a citation once officers returned from a traffic accident call.

OCPO Investigative Findings: OCPO recognizes in its investigation that Mr. Hafertepe has not provided the appropriate documentation that the state of Texas requires to be legally blind or disabled. Under Texas Penal Code § 22.04, Injury to a Child, Elderly, or Disabled Individual definitions in Texas. Texas Penal Code § 22.04(c) provides the following definitions for alleged victims: Child — A person 14 years of age or younger. Elderly Individual — A person 65 years of age or older.

Alleged offenders commit this crime if they intentionally, knowingly, recklessly, or with criminal negligence, by act or intentionally, knowingly, or recklessly by omission, cause bodily injury, serious bodily injury, or serious mental deficiency, impairment, or injury to a child, elderly individual, or disabled individual.

Disabled Individual -- A person with autism spectrum disorder, developmental disability, intellectual disability, severe emotional disturbance, and/or traumatic brain injury, or a person who otherwise by reason of age or physical or mental disease, defect, or injury is substantially unable to protect the person's self from harm or to provide food, shelter, or medical care for the person's self. (See Appendix A)

Mr. Hafertepe did not suffer any bodily injury and or physical pain during his attack on March 31, 2021, defined under Texas Penal Code § 1.07(8) bodily injury is defined under Texas Penal Code § 1.07(8) as being "physical pain, illness, or any impairment of physical condition." Texas Penal Code § 1.07(46) defines serious bodily injury as a "bodily injury that creates a substantial risk of death or that causes death, serious permanent disfigurement, or protracted loss or impairment of the function of any bodily member or organ." (See Appendix B). Mr. Hafertepe does not qualify for the State of Texas Penal Code's definition of a disabled person. Officers BWC footage captured Mr. Hafertepe stating that he felt no pain and the pipe barely grazed him. OCPO finds this allegation **Unfounded and cleared by body worn camera.**



- D) EC2021-0281: Mr. Hafertepe alleges officers failed to fully investigate the call by not contacting the suspected person who had assaulted him. OCPO confirms that the person in question, in this case, was found and cited by officers on March 31, 2021, at 4:26 pm. The offense was assault (contact) P.C.22.01 (A)(3) OCPO finds this allegation Unfounded.
- E) **EC2021-0289:** Mr. Hafertepe has made multiple reports with Dallas Police Department and believes that police have not done anything.

OCPO Investigative Summary: OCPO confirms The Dallas Police Department has followed up on complaints and allegations filed by Mr. Hafertepe. DPD IAD has given all information in his cases. OCPO has reviewed in its investigation Officers Officer's Body-Worn Camera footage, DPD Internal Affairs Division Report, Officer's Statements, Complainant Statements, and 911 Call recording **OCPO finds this Allegation Unfounded**.

F) **EC2021-0474:** Complainant alleges Officer Brandon Porragas Badge #11143 and Officer Zulema Quevedo Badge #11403 obtained incorrect information from him and entered incorrect information in report number 054815-2021

IAD Summary: No Investigation Warranted.

OCPO Investigative Summary: OCPO finds this Allegation is Unfounded and cleared by Officers Body Worn Cameras. Officer Brandon Porragas – Badge #11143 and Officer Zulema Quevedo – Badge #11403 obtain information given by Mr. Haferetep during their interaction at the scene. Officers followed up by calling information on the radio and provided Mr. Hafertepe information on what to do if approached by the suspect again. DPD rendered full service in Mr. Hafertepe's incident.

Case #2

IAD Case No: DR-2021-050 (EC2021-0318

Occurred date: March 31, 2021

DPD Investigative Department: Southeast Patrol Division

Involved Officers: (1) Officer Brandon Porragas - Badge # 11143

(2) Officer Zulema Quevedo - Badge # 11403

Classification/Sub-classification: Divisional Investigation Citizen Impact/Improper or No Investigation.

Synopsis of Incident: On March 31, 2021, at approximately 2:30 p.m. Mr. Hafertepe was assaulted and called the police. Police officers arrived and gave him a case number but did not talk to the suspected person. A car accident occurred during this incident, at which time the officers



left the scene of Mr. Hafertepe's incident and handled the accident. Once the officers completed the accident, they did not return to Mr. Hafertepe to finish talking. Mr. Hafertepe believes the officers failed to fully investigate for not talking to the suspected person or Mr. Hafertepe prior to leaving.

Complainant's Statement: Mr. Hafertepe states that he is legally blind and said he could not write. Detective Maldonado #10714 took his verbal statement and wrote it for him. Mr. Hafertepe believes the officers failed to fully investigate for not talking to the suspected person or Mr. Hafertepe prior to leaving.

Findings of Division Referral: Body worn camera video shows that the officers investigated the incident and generated a report with what information they had at the time. Furthermore, they later supplemented the original report with an At Large Citation for Class C Assault under citation # C22006750. The Allegation, therefore, is **Unfounded.**

OCPO Investigative Findings: OCPO, during its Investigation, was unable to establish a violation of departmental rules and or regulation in this case. OCPO classifies this allegation as **Unfounded.**

Case # 3

IAD Case No: EC2021-0339

Occurred date: March 31, 2021

DPD Investigative Department: Internal Affairs Division

Synopsis of Incident: Mr. Hafertepe alleges Senior Corporal Koerner failed to thoroughly investigate when he refused to reclassify the offense to a felony based upon his disability.

IAD Findings: No Investigation. This was already reviewed in DPD Case DR2021-050 and was Not Sustained.

OCPO Investigative Finding: OCPO in its investigation, was unable to establish a violation of departmental rules and or regulation in this case. OCPO classifies this allegation as **Unfounded. Please see Case #1 for a full explanation.**

Case #4

IAD Case No: EC2021- 0629

Occurred date: N/A

DPD Investigative Department: Internal Affairs Department



Synopsis of Incident: Mr. Haferetpe alleges he was assaulted, and DPD is not acknowledging the fact that he is disabled. The complainant would like to see the homeless man get a Class A citation for his actions.

IAD Findings: No investigation because there were no DPD policy violations.

OCPO Investigative Summary: On May 5, 2021, Mr. Hafertepe was interviewed by DPD Detective Koerner. At that time, Mr. Hafertepe could not provide Detective Koerner with the proper paperwork based on the Texas Penal Code 22.04. as proof that he was disabled or had a disability. OCPO classifies the allegation as **Unfounded:** No DPD policy violations.

Case #5

IAD Case No: EC2021-0687

Occurred Date: March 31, 2021

DPD Investigative Department: Internal Affairs Division

Synopsis of Incident: Complainant spoke with the DPD Open Records Department, who informed him there was no body worn camera video footage available for his complaint due to his request being 90 days past the incident date. The complainant requested to talk to IAD. Mr. Hafertepe inform Detective Maldonado he believed the video should be kept longer than 90 days. After Mr. Hafertepe verbally told Detective Maldonado his concerns, he chose not to make a complaint and completed a sworn statement reflecting its unwillingness to provide his statement at this time.

DPD IAD Findings: No investigation because there were no DPD policy violations.

OCPO Investigative Findings: On August 4, 2021, Mr. Hafertepe was sent a response from Sergeant Nancy Jones #7167 of the Internal Affairs Division (IAD) regarding his request to get BWC footage for his case. In the letter Sgt. Jones informed Mr. Hafertepe that she contacted the Open Records Unit and spoke with Manager III Shannon Cook. Sgt. Jones let Mr. Hafertepe know that his request was being fulfilled. Sgt. Jones also let Mr. Hafertepe know, there was an issue with one of his recordings. Sergeant Daniel Mosher #8655, reached out to Mr. Hafertepe and played the video recording for him in its entirety in the Internal Affairs division via a desktop computer.

OCPO Investigational Findings: OCPO confirms that the Dallas Police Department Open Records Department only keeps BWC footage 90 days past the incident date if there was no arrest. If an arrest had occurred in this case, Open Records would save the BWC footage for two years. **OCPO finding for this complaint is Unfounded:** No DPD policy violations.

Case #6

IAD Case No: E.C. 2021-0708

Occurred date: March 31, 2021

DPD Investigative Department: Internal Affairs Division

Synopsis of Incident: Complainant Mr. Hafertepe submitted a letter concerning his past complaints, and he requested that it be given to DPD Chief Eddie Garcia so he could read it.

DPD IAD findings: No investigation because there were no DPD policy violations

OCPO Investigative Finding: OCPO in its investigation of the complaint finds No DPD policy violations. **Unfounded.**

Case #7

IAD Case No: E.C. 2021- 0716

Occurred date: March 31, 2021

DPD Investigative Department: Internal Affairs Department

Synopsis of Incident: Complainant spoke with Open Records Department, and they do not have BWC from his incident. The complainant alleges he was assaulted, and DPD is not acknowledging the fact that he's disabled.

IAD Findings: No investigation because there was no DPD policy violation.

OCPO Investigative Findings: OCPO, in its investigation of the complaint, finds No DPD policy violations. **Please see duplicate complaint case #1(A) for full explanation.**

Case #8

IAD Case No: D.R. 2021-114 (EC-2021-0743)

Occurred date: July 19, 2021

DPD Investigative Department: Personnel Division

Involved Officers: (1) Officer Faerie Phelps #9018

(2) Senior Corporal Demarquis Fontaine Black #7574

DPD Allegation: Discourtesy/Unprofessionalism



Synopsis of Incident: Mr. Samuel Hafertepe alleges that on the listed date at approximately at the listed time, an officer at the front desk was rude and inconsiderate.

Based on Mr. Hafertepe's description, the officer may have been Officer Black or Officer Phelps; he was not sure.

Complainant Statement:

On Monday, August 16, 2021, at approximately 11:23 am, Sgt. Cindy Smith #6973 contacted Mr. Hafertepe and asked him about his contact with officers at the front desk of police headquarters. Mr. Hafertepe said he did not have a specific complaint towards the officers and that there was no specific comment or action done towards him that he could recall.

Statement of Senior Corporal Demarquis Black: Senior Corporal Demarquis Black #7574 stated he does not recall interacting with Mr. Samuel Hafertepe. He has at no time been rude or inconsiderate while performing his duties at the front desk.

Statement of Officer Faerie Phelps: Police Officer Faerie Phelps #9018 stated he did not recall any interaction with Mr. Hafertepe on the day in question.

Findings of the Division Referral: Not Sustained

On Monday, July 19, 2021, at approximately 10:00 am, Mr. Hafertepe stated he was at Dallas Police Headquarters and was treated rudely by an officer at the front desk.

Mr. Samuel Hafertepe was notified on September 9, 2021, that the complaint filed against a member of the Dallas Police Department had been investigated by their chain of command. The investigation was unable to establish a violation of departmental rules based on a preponderance of the evidence. The investigation was reviewed by Deputy Chief of Police William H Griffith II #5857 on November 16, 2021, at 08:51. He approved the decision.

OCPO Investigative Findings: OCPO in its investigational review of the complaint was not able to reach a conclusion based on the information given in the Division Referral. **Inconclusive**

OCPO Concerns:

- 1. OCPO requested to speak with two officers involved and their supervisor. There was no acknowledgment of the request.
- 2. The investigation conducted by DPD states that the only thing that Sergeant Cindy Smith did after speaking with Mr. Hafertepe to verify his allegations was to (1) narrow down who the officers were that could have been at the front desk that morning and (2) ask Senior Corporal Demarquis Black #7574 and Officer Faerie Phelps #9018 if they remembered interacting with Mr. Hafertepe in the lobby of police headquarters on July 19, 2021.

- 3. OCPO is concerned about the sufficiency of this investigation because of several factors:
 - On any given day police headquarters gets lots of people coming into the lobby requesting help with various issues.
 - The incident happened on July 19, 2021, and the officers were not questioned about their possible interaction with Mr. Hafertepe until months later: Senior Corporal Demarquis Black #7574 on August 30, 2021, and Officer Faerie Phelps #9018 on September 21, 2021.
 - What did Sgt. Smith do to ensure that Senior Corporal Demarquis Black #7574 was recalling all the morning events of July 19, 2021, accurately since he was questioned 43 days after the alleged interaction?
 - What did Sgt. Smith do to ensure that Officer Faerie Phelps #9018 was recalling all the morning events of July 19, 2021, accurately since he was questioned 65 days after the alleged interaction?
 - Did Sgt. Smith do any independent investigation of the matter like request surveillance camera footage from July 19, 2021, to see if she could see Mr. Hafertepe interacting with anyone in the lobby of headquarters. Even if there is no sound, she may have been able to observe body language during the interaction.

Without knowing the answers to these questions, OCPO cannot say with certainty that the DPD Personnel Department completed a thorough, accurate and complete investigation of this complaint.

OCPO Recommendation Regarding Case 8:

OCPO recommends that IAD find out the answer to the questions listed above and let OCPO know their findings so the information can be passed onto the CPOB for further consideration of this matter.

On March 30, 2022, CPOB Chairman Enobakhare, Jr., OCPO Director McClary, IAD Major Irene Alanis, and Deputy Chief Monique Alex (representing the Chief's Office) meet to discuss ways IAD, OCPO, and CPOB could improve communication.

The discussion was fruitful, and several suggestions were made and adopted that will hopefully improve communication between OCPO and DPD. Please see below:

- 1. For investigation cases that involve a division referral, IAD will work with OCPO to help ensure that a member of the Division's Command Staff attends the monthly CPOB meetings to answer questions about investigations.
- 2. OCPO will send CPOB members and IAD completed investigations and complaint reviews a week prior to the monthly CPOB meetings.
- 3. IAD staff will review the materials provided by OCPO and be prepared to answer questions at the CPOB monthly meeting. IAD will also forward paperwork related to division referrals to Division Command Staff so they will be prepared to answer questions at the CPOB monthly meeting.

Chairman Enobakhare, Jr. will check in with OCPO and IAD periodically to see how the new system is working.

SUBJECT UPDATE: Hiring OCPO Mediation Program Director

Ordinance 31192 calls for a mediation process as a possible way to handle complaints. OCPO is creating the process and will work with DPD and appropriate City of Dallas leaders and stakeholders to finalize the process.

To help the OCPO Director create and then administer the Mediation Program, OCPO is hiring a Mediation Manager that will oversee the day-to-day operations of the Mediation Program as well as supervise the pool of mediators that will be a part of the program.

OCPO is in the final stages of that hire. When the job description was posted and advertised, Director McClary asked Human Resources to do an initial screen for qualified applicants and 58 applications were forwarded to OCPO.

Director McClary working with an expert in the development of mediation programs for oversight offices narrowed the applicant pool down to 8 people for initial interviews.

After interviewing the initial pool, 4 applicants were selected to move forward to the final round of interviews which were conducted the week of March 28th. Director McClary is excited about the applicants in the final pool and is in the process of checking references for the final candidates and will hopefully be making an offer to one of the finalists the week of April 18th.

The goal is to have the Mediation Manager start within 30 days or less of acceptance of the position.

The interview team was made up of 4 people: Director McClary, 2 experienced mediators in the field of police oversight and a Dallas community member that was part of the Dallas Police Oversight Coalition.

Director McClary wants to thank the three of them for all the time they spent reviewing applications, interviewing candidates, and discussing the candidates.





External Complaint Workflow Process



External Complaint Workflow No Investigation Sub-Classification General Definitions

It is the policy of the Department to accept and investigate all complaints of misconduct or wrongdoing from any citizen as prescribed by state law and Department policy. Complaints are handled in accordance with Texas Government Code, Section 614.021-614.023, as interpreted by the City Attorney.

A No Investigation (NI) number is assigned to information received in the Internal Affairs Division that does not meet the guidelines of a complaint requiring a full investigation by the Department. The information is given a sub-classification for statistical tracking purposes. The current sub-classifications used are:

- Does not meet criteria- Complaints relative to differences of opinion between a citizen and the investigating officer regarding the contributing factors listed on an accident report will not be investigated. If a person calls or comes in but does not want to provide a written statement at that time, it will be entered. If they fail to follow up and provide a written complaint in any format, it may result in this sub-classification.
- Duplicate Complaint- Person is making a repeated allegation that has already been handled by the department.
- Fail to Articulate- Person may be complaining but does not make an allegation of misconduct.

Guilt or Innocence-

- Complaints relative to differences of opinion between a citizen and an arresting police officer regarding the guilt or innocence of that citizen will not be investigated but will be properly disposed of within the judicial system. If a citizen can furnish evidence that the arrest was malicious and/or illegal, the complaint may be investigated at the discretion of the Internal Affairs Division Commander.
- Complaints relative to differences of opinion between a police officer and a citizen over the issuance of a traffic citation will not be investigated unless there is an allegation of a violation of law or departmental rules on the part of the officer.
- Information Only- A person may just be sending information or needing something from a
 member of the department. For instance, needing a detective to call them back about a
 case. A complaint about having to wait a long time for a police response to a 911 call may
 receive this sub-classification. Information is forwarded to division of responsibility.
- More Information- Person makes an allegation of misconduct, but the department needs more information to make determination on how to proceed.

- No Violation- Preliminary investigation is able to determine, based on evidence available, there is no violation of department procedures. Complaints involving a citizen's misunderstanding of departmental policy, which are resolved by a supervisor explaining the correct departmental policy and where the citizen is satisfied with the response, will not require investigation.
- No Violation BWC- Preliminary investigation is able to determine there is no violation due to review of officer's body worn camera.
- Non-Employee- Person makes allegation into misconduct of person who is not an employee of the police department.
- Sixty Day- Complaints are not typically accepted more than sixty days after the alleged incident, with the following exceptions:
 - When the complaint involves a criminal violation, the criminal statute of limitations will prevail.
 - When the complainant can show good cause for not making the complaint within the specified time limit.
- Third Party- Person complaining has no direct knowledge of incident. Often used when
 person sends an email or letter after seeing a negative news or social media story.

In all case, the citizen is sent a return letter to inform them that the information or complaint has been received and how it will be handled. If the department is not going to investigate, the reason is given with contact information on who they may call to discuss.
