The vote was 11-2 (Williams and Woods voting Nay; Barbee and Toynes Absent).

BACKGROUND

The Dallas Rowing Club's (Club) primary objective is to promote the sport of rowing for all ages. By City Council Resolution No. 07-3500 adopted on November 28, 2007, the City of Dallas Park and Recreation Department entered into a License Agreement with the Dallas Rowing Club for use of Bachman Lake for the construction, operation and maintenance of a boathouse. The term of the agreement was for ten (10) years with two (2) five-year options to renew. This agreement expired November 2017. A new request for proposals was issued and the Dallas Rowing Club was the only proposer.

The Dallas Rowing Club was incorporated as a Texas Non-Profit Corporation on October 6, 1980. The Club has over 100 rowers, including participants from high school programs and offers basic rowing training. The Dallas Rowing Club may use the water surface of Bachman Lake for boating activities under the same conditions as the general public. The Club may exercise control over the shoreline and water surface immediately adjacent to the Club's facilities for the purpose of launching and retrieving boats.

The facility includes a boathouse building of approximately 6,200 square feet, along with stalls, moorings, docks and storage facilities. The Club is responsible for furnishing all equipment and security of the facility. The agreement would commence on city council approval.

The following responsibilities between the Dallas Park and Recreation Department and the Dallas Rowing Club are for consideration:

THE DALLAS ROWING CLUB RESPONSIBILITIES:

- 1. The Club shall occupy the premises and maintain its improvements to the premises, as necessary, subject to the specific terms and conditions of this Agreement.
- 2. The Club shall at its sole cost and expense, keep and maintain the premises and all facilities in good order and repair and, in a safe, clean, sanitary and attractive condition.
- 3. The Club agrees to coordinate such ground maintenance with the designated Park and Recreation Department staff responsible for the Park if it conducts a special event requiring additional grounds maintenance.
- 4. The Club may only encumber the Club's personal property for the purpose of constructing improvements on the premises, and the City agrees that such removable personal property may be pledged as collateral pursuant to the terms of this paragraph.
- 5. No lien of any kind may legally be asserted or perfected against any property of the City, including any buildings or permanent fixtures erected thereon.
- 6. All fixed improvements on the premises shall become the property of the City upon the earlier of acceptance by the Director or the termination of this Agreement, unless such improvements have not been approved (as determined by the Director), in which case the Club shall at City's request, remove the improvements and return the premises to materially the condition that existed on the effective date of this Agreement no later than sixty (60) business days following the termination of this Agreement.
- 7. The Club shall pay to the City \$1,000 per year as an annual Club and rental fee. Payment is due to the City the first of the month following 120 days after the date of execution of this Agreement and on each annual anniversary date thereafter, due and payable immediately upon demand, until the expiration or termination of this Agreement.

THE CITY OF DALLAS PARK AND RECREATION DEPARTMENT RESPONSIBILITIES:

1. The City shall continue to maintain the park grounds in the immediate vicinity of the premises on its current schedule.

TERMINATION:

1. The term of this agreement shall be ten-years with two five-year renewal options and shall terminate ten (10) years thereafter, unless terminated at an earlier date in accordance with the terms of this Agreement. The Club shall have the right to access the premises upon execution of this Agreement for purposes of making renovations and other improvements.

If WRBH fails to maintain the Premises as herein required, the City may enter the Premises fourteen days after giving written notice to the WRBH of failure to maintain the Premises, and WRBH shall pay the City all reasonable and necessary costs and expenses incurred to remedy any such failure to maintain the Premises.

BACKGROUND

On September 1, 1998, the City entered into a 20-year Management Agreement with The Conservancy to restore, maintain and operate Oak Lawn Park (Lee Park) and Arlington Hall (formally known as Arlington Hall at Lee Park). On January 30, 2018, the City approved the first of two five-year renewals which will go into effect on September 1, 2018. This Agreement allows the Conservancy to set user fees for rentable facilities (the Hall and related areas) with Park Board approval.

The Conservancy has maintained set rates since 2015 with no price increases or instituting new fees. In response to marketplace demand, to continue meeting financial needs, and to continue maintaining the property while funding future projects, the Conservancy is requesting approval to increase certain rates while creating new fees for associated with use of specific park areas.

The Conservancy reserves various room and terraces within Arlington Hall which accommodates both large and small groups or events. BACKGROUND

Built in 1930 on the shore of White Rock Lake, the "Old Bath House" was one of the first uses of Art Deco architecture in the southwest. The building provided lockers, changing rooms, rentable swim suits and concessions for the thousands of people that drove from all over North Texas to swim in the lake.

The Bath House remained a social and recreational location for over two decades, but was closed in 1953 when swimming in White Rock Lake was discontinued. The building sat vacant until 1978 when, supported by a dedicated group of neighborhood arts activists, the City of Dallas announced plans to restore the building.

In August of 1981, the citizens of East Dallas celebrated the birth of the City's first neighborhood cultural center that includes a 116-seat theater, two gallery spaces, and several multipurpose spaces. Visual and performing artists from an array of backgrounds find a welcoming venue for their work. The Center provides a place where artists and audiences meet to explore and enjoy the life force that is the arts that is consistently rated as one of the Top Attractions in the DFW Metroplex. Outside of the Bath House Cultural Center, there are three public art installations: A Place to Perform by Linnea Glatt, that supports outdoor performance and meeting space, Whirl by John Christensen-found in the garden area at the entrance to the Bath House and Resaca by Bradford Graves-also near the entrance to the Bath House.



BACKGROUND

On May 29, 2018, Public Art staff attended the Buckner Terrace HOA to discuss the new public art in Everglade Park. The HOA members in attendance (70+) voted to install artwork proximate to the Butterfly Garden instead of near the parking lot to provide a more highly visible and accessible location in the park based on how members of the community use the park.

The City of Dallas Office of Cultural Affairs Public Art Program identified 50 Pre-Qualified Emerging Artists that are eligible for projects with budgets of up to \$50,000. The Public Art Committee selected the 50 finalists for approval by the Cultural Affairs Commission, which accepted their recommendations in a unanimous vote during their meeting on Thursday, November 20, 2014.

The Public Art Program of the City of Dallas Office of Cultural Affairs requested the submission of qualifications from artists or artist teams to design, fabricate and install a work of public art at the entrance area between the pool and the basketball court at Everglade Park.

The City of Dallas Public Art Ordinance provides that all appropriations for City capital improvement projects shall include an amount equal to 1.5% (or .75%) of the total capital improvement project appropriation to be used for the design services of artists and for the creation of artworks for new City facilities (Dallas City Code Article X, SEC. 2-103(a). The public art project for the Walnut Hill Recreation Center was included in the list of 2006 Bond Fund Program public art projects approved by City Council on April 23, 2014, Resolution No. 14-0664.
