- 3) Install concrete pavers on Commerce and S. Ervay Streets.
- 4) Install two attached signs on north and south facades.
- 5) Install two projecting blade signs on west and south facades.

### **BACKGROUND / HISTORY:**

12/1/2014 – Landmark Commission approved the replacement of storefront and windows, construct an exterior stair, and removal of a non-historic penthouse. (CA145-063(MD)).

**ANALYSIS:** Since all requests meet the Allen Building preservation criteria, and the work has been reviewed and approved by the National Park Service in conjunction with a Federal Tax credit review (CX-, Staff is recommending approval.

- building site and landscaping in the Preservation criteria Section 3.2, and it meets the standards in City Code Section 51A-4.501(g)(6)(C)(i).
- 4) Install two attached signs on north and south facades. Approve Approve drawings dated 11/18/15 with the finding the proposed work meets the criteria for signage in the Preservation criteria Sections 9.1 and 9.2, and it meets the standards in City Code Section 51A-4.501(g)(6)(C)(i).
- 5) Install two projecting blade signs on west and south facades. Approve Approve drawings dated 11/18/15 with the finding the proposed work meets the criteria for signage in the Preservation criteria Sections 9.1 and 9.2, and it meets the standards in City Code Section 51A-4.501(g)(6)(C)(i).
