Or an affiliate for the development of a Public Safety Building/Fire Station 58 in the Cypress Waters TIF District and the conveyance of the property to the City, in an amount not to exceed \$12,300,000 for reimbursement of development costs associated with construction and conveyance, excluding the cost of the land.

- 6. Deliberations regarding economic development negotiations. Section 551.087 of the Texas Open Meetings Act.
- 7. Deliberations regarding security assessments or deployments relating to information resources technology, network security information, or the deployment or specific occasions for implementations of security personnel, critical infrastructure, or security devices. Section 551.089 of the Texas Open Meetings Act.
