- 2) **February 19th:** *Candlelight Vigil for Peace, Unity, Healing and Accountability*

SUBJECT REPORT: OCPO Mediation Program

Our conventional understanding of collaboration is that it requires us all to be on the same team and headed in the same direction, to agree on what needs to be done. In other words, we assume that collaboration must be under control. When we are working in complex situations with diverse individuals stretch collaboration abandons the assumption of control. It enables us to get things done even in complex situations with people we do not necessarily agree with. Stretch collaboration requires us to make three fundamental shifts in how we work.

First - In how we relate with our fellow collaborators —

Second- In how we advance our work —

Third- In how we participate in a situation—In the case of trauma and discontent we must show up and do more.

The OCPO Mediation Program has received several nominations for the community advisory committee. However, we are still gathering additional nominations. The OCPO Mediation Program uses committees to obtain independent expert advice on policy and process matters. The OCPO Mediation Program seeks to include the views of women, men, members of all racial and ethnic groups, and individuals with and without disabilities on its advisory committees and, therefore, encourages nominations of appropriately qualified candidates from these groups. The advisory committees are established to provide feedback that supports the program's mission of mediation and promoting better communication between DPD and the community while meeting the requirements outlined in the city's ordinance. The advisory committees are established at the discretion of the OCPO Mediation Program.

Below are a few items we completed in January:

- (1) Mediation Program successfully completed another **Lemonade with Laurie:** *How to work with people in times of disagreement when collaboration seems both imperative and impossible.* This was an amazing collaboration with CPOB member John Mark Davidson – District 15. The principles and teachings that were focused on during the webinar were undergirded with the teachings of Dr.

Martin Luther King, Jr. in celebration of his birthday. During his segment of the presentation, Board member Davidson referenced two books. To keep the education going from the webinar, the Mediation Program will be giving away 2 copies of each book to participants. The flyer for the event is attached.

SUBJECT: REPORT: January 2023 Officer Involved Shooting: Joey Fraire

During the month of January 2023 there was one Dallas Police Department officer involved shooting. OCPO attended the scene of the incident. This is the first officer involved shooting in 2023.

Below is a brief summary of the facts from DPD:

On January 25, 2023, at around 12:30 pm, Dallas Police Fugitive Unit officers were at 2500 Wilbur Street on an unrelated investigation. While on Wilbur Street, officers received a wanted persons bulletin and learned a suspect wanted for Capital Murder out of Farmers Branch was on the same block.

At around 2:00 pm, officers located the suspect, 18-year-old Joey Fraire, on Wilbur Street, seated in the front passenger seat of a car driven by an unknown male.

The Fugitive Unit members, Officers Joshua Gonzalez, Richard Whitt, Scott Neal, Victor Lucas, Aryn Hale, and Elliott Howell followed the car for about an hour, allowing additional resources to respond, and to find a location to arrest Fraire.

Officers followed the suspect, to 2546 Bahama Drive, the Bahama Glen Apartments.

At around 2:55 pm, officers attempted to take the suspect into custody in the parking lot, and a drone was deployed to assist officers.

At around 2:59 pm, as part of a high-risk apprehension, Fugitive Unit officers gave repeated verbal commands and deployed a distraction device, a flashbang, for the driver and Fraire to exit the vehicle.

The driver got out of the car and was taken into custody.

The suspect refused to show his hands, exit the vehicle or follow commands, and at 3:01 pm Fugitive Unit deployed pepper ball rounds. The suspect still did not exit the car.

At 3:02 pm, a Sergeant monitoring video from the drone operation announced over the radio, that Fraire had a gun in his right hand.

Also, at 3:02, a second flash bang was deployed and Fraire is seen with his gun, and fires at Dallas Police officers at least twice.

The officers returned fire, hitting the suspect multiple times. Fraire ran from the car and fell to the ground, dropping his weapon.

Dallas Fire Rescue was called at 3:02 pm and at 3:07 pm first aid was administered by Fugitive Unit officers until DFR arrived at 3:18.

Fraire was taken to a local hospital where he died from his injuries at 3:43 pm.

One Fugitive unit officer was shot in the left foot. He was taken to a local hospital, treated, and released.

The suspect's weapon was recovered at the scene and a second weapon was recovered near the driver's seat during a search of the car by detectives. The second weapon was modified with a Glock switch.

The investigation is ongoing and is being investigated by the Dallas Police Special Investigations Unit (SIU).

The Dallas County District Attorney's office was notified and responded to the scene and will conduct its own investigation.

The Office of Community Police Oversight was notified and responded to the scene.

The investigation is still being conducted by DPD at this time so OCPO cannot do an official investigation into the case. However, OCPO is monitoring the work of SIU and IAD as they conduct their investigations.





External Complaint Workflow

No Investigation Sub-Classification General Definitions

It is the policy of the Department to accept and investigate all complaints of misconduct or wrongdoing from any citizen as prescribed by state law and Department policy. Complaints are handled in accordance with Texas Government Code, Section 614.021-614.023, as interpreted by the City Attorney.

A No Investigation (NI) number is assigned to information received in the Internal Affairs Division that does not meet the guidelines of a complaint requiring a full investigation by the Department. The information is given a sub-classification for statistical tracking purposes. The current sub-classifications used are:

- **Does not meet criteria-** Complaints relative to differences of opinion between a citizen and the investigating officer regarding the contributing factors listed on an accident report will not be investigated. If a person calls or comes in but does not want to provide a written statement at that time, it will be entered. If they fail to follow up and provide a written complaint in any format, it may result in this sub-classification.
- **Duplicate Complaint-** Person is making a repeated allegation that has already been handled by the department.
- **Fail to Articulate-** Person may be complaining but does not make an allegation of misconduct.
- **Guilt or Innocence-**
 - Complaints relative to differences of opinion between a citizen and an arresting police officer regarding the guilt or innocence of that citizen will not be investigated but will be properly disposed of within the judicial system. If a citizen can furnish evidence that the arrest was malicious and/or illegal, the complaint may be investigated at the discretion of the Internal Affairs Division Commander.
 - Complaints relative to differences of opinion between a police officer and a citizen over the issuance of a traffic citation will not be investigated unless there is an allegation of a violation of law or departmental rules on the part of the officer.
- **Information Only-** A person may just be sending information or needing something from a member of the department. For instance, needing a detective to call them back about a case. A complaint about having to wait a long time for a police response to a 911 call may receive this sub-classification. Information is forwarded to division of responsibility.
- **More Information-** Person makes an allegation of misconduct, but the department needs more information to make determination on how to proceed.

- **No Violation-** Preliminary investigation is able to determine, based on evidence available, there is no violation of department procedures. Complaints involving a citizen's misunderstanding of departmental policy, which are resolved by a supervisor explaining the correct departmental policy and where the citizen is satisfied with the response, will not require investigation.
- **No Violation BWC-** Preliminary investigation is able to determine there is no violation due to review of officer's body worn camera.
- **Non-Employee-** Person makes allegation into misconduct of person who is not an employee of the police department.
- **Sixty Day-** Complaints are not typically accepted more than sixty days after the alleged incident, with the following exceptions:
 - When the complaint involves a criminal violation, the criminal statute of limitations will prevail.
 - When the complainant can show good cause for not making the complaint within the specified time limit.
- **Third Party-** Person complaining has no direct knowledge of incident. Often used when person sends an email or letter after seeing a negative news or social media story.

In all case, the citizen is sent a return letter to inform them that the information or complaint has been received and how it will be handled. If the department is not going to investigate, the reason is given with contact information on who they may call to discuss.
