SUBJECT: Dynell Lane Independent Investigation by OCPO

Part A: Background

At the September 12, 2023, CPOB meeting, the Board reviewed the complaint of Mr. Dynell Lane and voted for OCPO to do an independent investigation into the case.

Prior to the CPOB voting for the independent investigation, they heard from Mr. Lane during the public comment section on the matter. Special Investigator Kevin Williams also presented the findings of the Dallas Police Department's Internal Affairs Division (IAD) investigation and played body-worn camera (BWC) footage related to the complaint. IAD was available for questions from CPOB members.

During the public comments from Mr. Lane, the CPOB learned that he was a Sergeant in the United States Army and that he had been deployed to Afghanistan, Kuwait, and Iraq. While he was deployed, he sustained life-threatening injuries to his lower extremities that led him to be disabled. Mr. Lane explained how his disability led him to seek the assistance of two off-duty DPD officers on the night of June 10, 2023, who were working at a restaurant in Dallas called Serious Pizza. He also explained that he called 911 seeking assistance because of his interaction with those officers.

The BWC footage played by OCPO during the meeting did not capture the interaction between Mr. Lane and the two off-duty officers working at Serious Pizza. However, it did capture a conversation between the two officers who were dispatched to Serious Pizza in response to Mr. Lane's 911 call and the two off-duty officers working at Serious Pizza who had interacted with Mr. Lane earlier that evening.

During the Q & session regarding Mr. Lane's complaint, IAD informed the CPOB that they had not seen the BWC footage that was played prior to it being shown at the August 8th CPOB meeting.

Part B: News Coverage

Since the August 8th CPOB meeting, Mr. Lane's case has gone "viral". Meaning that the case has garnered not only national but international notoriety partially from members of the military. The media coverage started with an article written about Mr. Lane's case by the Dallas Morning News. The case was then picked up by all the major news outlets in Dallas and quickly spread to media outlets nationally and internationally.

Mr. Lane's case has also been picked up on social media. There have been several posts on YouTube, Tic Tok, and X (formerly Twitter) regarding Mr. Lane's case.

Part C: Public Concern & Outrage

Mr. Lane's case has struck a chord with men and women who have served in the military and others concerned about the case. The OCPO office has been receiving on average 10-15 calls and emails daily from people expressing their concern and/or outrage about Mr. Lane's case based on the BWC footage that they have seen.

DPD and OCPO have also received many written complaints about the incident. Because none of the complainants so far were actually involved in the incident between Mr. Lane and the DPD officers, those complaints have been classified as "No Investigations" because the complainants are third parties.

Part D: Update Regarding DPD Investigation

Mr. Lane filed his complaint with DPD on June 3, 2023. After reviewing the case IAD determined that the case would be classified as a "No Investigation" because they "were unable to establish a violation of departmental policies or procedures."

However, on August 16, 2023, OCPO Director McClary received an email from Major Irene Alanis who is the commanding officer in charge of IAD stating, "Be advised, I have opened an investigation on Mr. Lanes EC2023-0603 complaint."

Part E: Status of the OCPO Independent Investigation & Next Steps

As stated at the beginning of this memorandum, the CPOB voted for OCPO to conduct an independent investigation of the two complaints filed by Mr. Lane with IAD. OCPO was in the process of beginning their investigation when it received the email referenced above from IAD's Major Irene Alanis stating that IAD was going to conduct a formal investigation into the complaint.

Dallas City Code Sec. 37-32 (3) states the following:

W[w]hen the board is not satisfied with the findings of the police department internal affairs division's investigation of a critical [an] incident or external administrative complaint which is properly before the board [pursuant to Section 37 33], the board may direct the director to initiate [conduct] an independent [additional] investigation into the internal affairs division investigation of a critical incident or an external administrative complaint. (Emphasis added)

Based on this language OCPO has the authority to conduct an independent investigation at the conclusion of a DPD investigation. The "No Investigation" finding originally articulated by IAD gave the OCPO the authority to conduct an independent investigation. However, that finding has now been superseded by the notification to OCPO that IAD will launch a full investigation into the complaint.

Based on that notification, Special Investigator Williams was instructed to halt his investigation until OCPO receives the findings from IAD. Once OCPO receives those findings it will reach out to Mr. Lane to see if he is satisfied with the results of the IAD investigation or if he wants the CPOB to review the new findings by IAD.

OCPO is actively monitoring the IAD investigation of Mr. Lane's complaint and will keep the Board informed of this matter.

CPOB Discussion Regarding Potential Board Recommendation to the City that DPD Adopt and Implement Department of Justice Standards for Internal Investigations

At the August 8th CPOB meeting the Board began discussing the possibility of making recommendations to DPD to adopt and implement Department of Justice Standards for Internal Investigations.

The Board is reviewing two reports issued by the Department of Justice Office of Community Oriented Policing Services to review police investigative standards. One report is entitled: Standards and Guidelines For Internal Affairs: Recommendations from a Community of Practice. The other report in entitled: Building Trust Between the Police and the Citizens They Serve: An Internal Affairs Promising Practices Guide for Local Law Enforcement. This report looks at the Internal Affairs process from a citizen's viewpoint.

CPOB Vice Chairman Jose Rivas drafted some recommendations for consideration by the CPOB to address some of the concerns raised. (See attachment). At the September 12, 2023, CPOB meeting Chairman Enobakhare, Jr. asked the CPOB Policy Subcommittee to review Vice Chair Rivas's recommendations and bring a report back to the CPOB at the October 10th meeting.

CPOB Policy Subcommittee Chair Brandon Friedman will hold a meeting of the CPOB Policy Subcommittee to review the recommendations. He will give a report at the CPOB October monthly meeting.

Subject: REVISION - DPD GENERAL ORDERS SECTION 505.01

Encl: (1) Dallas Police Department General Orders 505.01

- 1. Mr. Chairman, the proposed recommendation, paragraph 3, is submitted for inclusion in the September 2023 agenda for board discussion and referral to the CPOB Policy Subcommittee. This recommendation is in keeping with the Mayor and City Council's progress towards transparency, accountability, and trust-building in city governance, which we most recently observed in June 2023 with the city council's amendment of the city code pertaining to major ethics reform and rebuilding trust in the city government.
- 2. DPD General Order, 505.01, paragraphs (a) and (b) will be affected by the revision. Enclosure (1) pertains.
- 3. The new text reflecting revision is:

505.01 Complaint Classification

- A. Complaints received from citizens that do not allege or suggest an officer's unreasonable use of force, regardless of where the citizen first reports the complaint, will be classified as an External Administrative Complaint.
- B. Complaints from officers and supervisors within the Department that do not allege or suggest an officer's unreasonable use of force will be classified as an Internal Administrative Complaint.
- C. Complaints received from citizens, officers, or supervisors that allege or suggest that an officer's use of force was willfully, intentionally, recklessly, or knowingly excessive or unreasonable will be classified as a criminal complaint and investigated as such through the Public Integrity Unit. The Office of Community Police Oversight will be provided visibility into the progress of the investigation.

4. In closing, this recommendation is reasonable in that it advocates for a fair and thorough investigation of resident complaints regarding allegations of unreasonable use of force short of serious bodily injury or death. This recommendation also supports the Chief of Police's officer accountability strategy and builds trust through transparency for residents and the board and assuages police officer concerns through the use of known internal investigative checks and balances.

SUBJECT: REPORT: September Officer-Involved Shooting:

During the month of September 2023, there were two Dallas Police Department officer-involved shootings, this is the 9th and 10th Officer-involved shooting for the year 2023.

Below is a summary of the facts from the September 2023 Dallas Police Department officer-involved Shooting:

1 # On September 14, 2023, at about 1:30 p.m., Dallas Police Officers Derek Williams and Christopher Mazin were driving past a business located at 4847 Scyene Road when they saw the suspect, later identified as 45-year-old Juan Vicente Zavala Lopez, shooting into a vehicle.

The officers turned into a nearby business parking lot and got out of their vehicles with their duty weapons drawn. Zavala Lopez, fired several times at officers as he pulled out of the parking lot, hitting the patrol car

Officers Williams and Mazin both returned fire at the suspect got back into their patrol car and chased the suspect to the 4800 block of 2nd Avenue.

The suspect was traveling southbound on Second Avenue, abruptly did a U-turn, and drove back toward the officers who got out of their vehicle. The suspect and Officer Williams exchanged gunfire as the suspect passed.

Officer Williams was hit by the suspect on his right side in his ballistic vest. The squad car was hit again, several times. Officer Williams was taken to a local hospital for treatment and later released. Officer Mazin was not injured.

The victim in the initial shooting on Scyene, Ruperto Mondragon Salgado, 60, died at the scene. Another man inside the vehicle was not injured. A search was immediately started for the suspect. The investigation led detectives and the search to the city of Lewisville and a private home in the 2300 block of South Valley Parkway. The Dallas Police Fugitive Unit coordinated with Dallas Police SWAT and Lewisville Police to take the suspect into custody.

The suspect was in a barn on the property and taken into custody by Dallas SWAT. Zavala

Lopez was taken to a local hospital for treatment for a gunshot wound to his leg.

He has been charged with Murder one count of Aggravated Assault in the homicide on Scyene, and four counts of Aggravated Assault Peace Officer. He was taken to the Dallas County Jail.

The investigation is ongoing and is being investigated by the Dallas Police Special Investigations Unit.

The Dallas County District Attorney's office was notified and responded to the scene and will conduct its investigation. The Office of Community Police Oversight was notified and responded to the scene.

The suspect has been identified as 45-year-old Juan Vincente Zavala Lopez. He has been charged with Murder one count of Aggravated Assault in the homicide on Scyene, and four counts of Aggravated Assault Peace Officer. He was taken to the Dallas County Jail.

2 # Dallas Police Investigate Officer Involved Shooting at Barnes Bridge and El Capitan

Dallas Police continue

Dallas Police continue to investigate the officer-involved shooting that happened on September 24, 2023, in the 1800 block of Barnes Bridge Road and 2000 block of Barnes Bridge Road.

This is the tenth officer-involved shooting involving a Dallas Police Officer in 2023.

On September 22, 2023, Northeast covert officers were on normal patrol when they saw a silver Cadillac SUV with a paper tag that did not belong to the vehicle. Officers attempted a traffic stop, but the driver took off and there was no pursuit. On September 24, 2023, at about 12:30 a.m., covert officers saw the same SUV westbound on Garland Road near Peavy Road, this time, with a different paper tag that did not belong to the vehicle.

The covert officers followed the vehicle to the 1800 block of Barnes Bridge Road and requested uniformed officers to the address. Officers Francis Vela and Oscar Macias responded to the scene. When the uniformed officers arrived, they saw the suspect, later identified as 55-year-old Michael Shirley, outside the suspect vehicle.

The officers gave verbal commands to Shirley to stop and show his hands. Shirley then pulled out a handgun from a shoulder holster. Officer Vela fires her weapon at Shirley, and the suspect fires back.

Officer Vela continues to fire and Senior Corporal Andrew Pease, a covert officer on-scene, also fires his weapon at Shirley. Shirley continued to shoot, then got back into the stolen vehicle and sped northbound on El Capitan into a nearby apartment complex.

The suspect cut through the complex and came out eastbound onto Barnes Bridge Road. The suspect hit a curb and flipped the SUV in the 2000 block of Barnes Bridge.

Senior Corporal Andrew Peace and Officer Richard Reiniger saw the suspect vehicle crash and approached the suspect vehicle on foot from the east. Officers Peace and Reiniger were wearing heavy vests with police markings and carrying patrol rifles.

Officers Vela and Macias approached from the west and Shirley fired at them for a second time. Officers Pease and Reiniger took cover behind a parked vehicle and returned fire at the suspect.

The suspect was hit by the return gunfire and fell to the ground. A drone was deployed, showing the suspect still on the ground and the suspect's weapon lying next to him in the grass. Officers approached the suspect with shields and placed him in custody.

Officers administered first aid until DFR arrived, but Shirley died at the scene.

The drone footage also showed another person still inside the vehicle. The woman inside the vehicle was not injured.

The woman said that she had gotten into the suspect's vehicle voluntarily and as she and the suspect drove around, the suspect pulled her into the second-row seat of the vehicle and handcuffed her to the seatbelt. She is not considered a suspect and was not charged. The suspect's weapon was recovered at the scene.

One DPD vehicle was hit twice by gunfire. Once in the driver's side window and once in the driver's side front fender. An uninvolved vehicle, on Barnes Bridge Rd. was also hit by gunfire officers were hit by any rounds fired by the suspect, and no officers were injured.

Offense reports were filed in this case for Shirley including four counts of Aggravated Assault Public Servant and one charge of Kidnapping. All charges will be cleared by exceptional arrest.

The Dallas Police Special Investigations Unit is investigating this case. The Dallas County District Attorney's Office was notified. The Office of Community Police Oversight was notified.

SUBJECT Board Training Schedule

The CPOB is not only committed to community engagement, but also to continue learning in the areas of oversight, policing, criminal justice, and any other topics the Board deems relevant to its work.

Below is the proposed training

Training

2-hour Zoom training, starting with an introduction and overview of the available data (police incidents, arrests, arrest charges, and use of force) and then a short skills tutorial going through the basics of downloading and working with the data.

We would then like to put them into small groups (2-3 people) to work with the data in breakout rooms, ideally, each working with a different data set and then reporting back on their findings. This would be what they found, what they would like to do with the data, and what questions they have about the data.

We would like to finish by offering some case studies from other jurisdictions on how data has been used for oversight and change in various departments.

Outcome

Our hope is that this will not only give them some good context but also some personal experience working with the data no matter what their skill level that should prove useful.

Former Director McClary shared the proposal with CPOB Chairman Enobakhare, Jr., CPOB Vice Chairman Jose Rivas, CPOB Training Subcommittee Chair David Kitner, and CPOB Data & Technology Chair Alan Marshall. They all agreed that the training would be worthwhile, and they wanted the proposal to be shared with the entire CPOB.

Director Chandler will work with Mr. Dunks and Mr. Higgins to get the training scheduled by the end of the year.
