SUBJECT: Dynell Lane Independent Investigation by OCPO

Part A: Background

Mr. Lane filed a complaint with DPD on June 3, 2023. After reviewing the case IAD determined that the case would be classified as a "No Investigation" because they "were unable to establish a violation of departmental policies or procedures."

After receiving the results of the investigation from DPD's Internal Affairs Division (IAD), Mr. Lane filed an appeal with the CPOB. At the August 8, 2023, CPOB meeting, the Board reviewed the complaint of Mr. Dynell Lane and voted for OCPO to do an independent investigation into the case.

OCPO was in the process of beginning their investigation when it received an email from Major Irene Alanis who is the commanding officer in charge of IAD stating, "Be advised, I have opened an investigation on Mr. Lanes EC2023-0603 complaint."

Part B: Status of the OCPO Independent Investigation & Next Steps

Based on that notification from IAD, former OCPO Director McClary instructed OCPO Special Investigator Williams to halt his investigation until OCPO receives the findings from IAD.

In the September 12th CPOB meeting Major Alanis informed the Board that IAD was actively conducting the investigation. She stated that her desire was that the investigation be concluded as soon as possible. To help expedite the conclusion of the investigation, she has limited the caseload of the detective handling the Lane investigation. That detective will only work on the Lane case until the investigation is concluded. In the October 10th CPOB meeting Major Alanis informed the Board that the Lane investigation was drafted and under review.

OCPO is actively monitoring the IAD investigation of Mr. Lane's complaint. Vice Chair Rivas has asked that IAD give the Board an update on the investigation in the December CPOB meeting.

Encl: (1) Dallas Police Department General Orders 505.01

- 1. Mr. Chairman, the proposed recommendation, paragraph 3, is submitted for inclusion in the September 2023 agenda for board discussion and referral to the CPOB Policy Subcommittee. This recommendation is in keeping with the Mayor and City Council's progress towards transparency, accountability, and trust-building in city governance, which we most recently observed in June 2023 with the city council's amendment of the city code pertaining to major ethics reform and rebuilding trust in the city government.
- 2. DPD General Order, 505.01, paragraphs (a) and (b) will be affected by the revision. Enclosure (1) pertains.
- 3. The new text reflecting revision is:

505.01 Complaint Classification

- A. Complaints received from citizens that do not allege or suggest an officer's unreasonable use of force, regardless of where the citizen first reports the complaint, will be classified as an External Administrative Complaint.
- B. Complaints from officers and supervisors within the Department that do not allege or suggest an officer's unreasonable use of force will be classified as an Internal Administrative Complaint.
- C. Complaints received from citizens, officers, or supervisors that allege or suggest that an officer's use of force was willfully, intentionally, recklessly, or knowingly excessive or unreasonable will be classified as a criminal complaint and investigated as such through the Public Integrity Unit. The Office of Community Police Oversight will be provided visibility into the progress of the investigation.

4. In closing, this recommendation is reasonable in that it advocates for a fair and thorough investigation of resident complaints regarding allegations of unreasonable use of force short of serious bodily injury or death. This recommendation also supports the Chief of Police's officer accountability strategy and builds trust through transparency for residents and the board and assuages police officer concerns through the use of known internal investigative checks and balances.

During the month of November 2023, there was one Dallas Police Department officer-involved shootings on November 16.

Below is a summary of the facts as reported by DPD regarding the November 2023 Dallas Police Department officer-involved Shooting:

The Dallas Police Department continues to investigate the officer-involved shooting that occurred on November 2023, in the 9900 Adleta Blvd. This is the eleventh officer-involved shooting involving a Dallas Police officer in 2023.

On November 16 2023, at approximately 6:05A.M., U.S. Marshals North Texas Fugitive Task Force served a Captial Murder arrest warrant for the Jordan Owens.

Members of the Task Force began making their presence known by knocking and moving toward the individual with the intent to serving the warrant at the apartment.

Officers breached the door after the suspect willfully refused.

Once the door was opened, the suspect fired several rounds, striking Senior Corporal Edgar Morales in the left calf. Senior Corporal Morales returned fire with his rifle.

First Aid was administered to Senior Corporal Morales's wound; he was later transported to Presbyterian Hospital. The suspect proceeded to break out the window and began throwing items in the parking lot.

Officers gave verbal commands to the Suspect, but the Suspect did not comply. The Suspect was seen with the weapon in and outside the apartment.

The suspect proceeded to break out the window and began throwing items in the parking lot.

At 6:12A.M. Officer Kurt Hibbets fired one round from his rifle at the armed Suspect.

The Suspect continued to wave his weapon and threatened to shoot Officers.

At 6:15A.M., Officer Barrett Nelson fired three rounds from his rifle at the armed suspect.

The suspect continued to be noncompliant and make threatening remarks toward the Officers while brandishing his weapon.

At 6:19A.M., the Suspect uses threatening profane language toward the officers. Officer Nelson and U.S. Marshal Sanders fired their rifles at Suspect.

A female occupant of the apartment complex called 9-1-1 and notified the operator there were other occupants inside the apartment and the Suspect was injured.

The Task Force Officers then evacuated the occupants and challenged the Suspect in the living room of the apartment where he was taken into custody.

First Aid was administered to the Suspect; as he suffered wounds on the torso, shoulder, right forearm and forehead.

He was transported to Presbyterian Hospital by Dallas Fire Rescue; where he is in stable condition in the neuro-ICU.

Synopsis of Incident

Original Complaint filed 01/14/2023 filed a complaint stating that Dallas Police Officers entered incorrect information regarding his accident report he filed with the Dallas Police Department. The

complaint was reviewed and an investigation was conducted. On 10/19/2023 a letter was sent to complainant advising him that DPD was unable to establish a violation of departmental rules. On 11/20/23 complainant filled a civilian review form asking for his case to be reviewed. The complainant alleged that DPD Officers racially profiled him and falsified information in his report by not listing the correct S amount of damage to his car in the report. The officers were notified of the mistake and corrected the report with a supplement to reflect the appropriate amount of damage. OCPO reviewed the BWC of the incident and noted that during the incident did not ask for a specific value of damage from the complainant.

DPD Internal Affairs Investigation Summary:

The complaint you filed against a member Of the Dallas Police Department has been thoroughly investigated. We regret that your contact with the Police Department was less than satisfactory. It is our goal that each contact with a member of our department be one in which we display the highest degree of professionalism possible, In the case of your complaint, the investigation was unable to establish a violation of departmental rules. The investigation will still be reviewed by the employee's supervisor to determine if any training or other action would be appropriate to improve our performance.

Part B.

Complainant Terasius Jefferson Synopsis of Incident: I Terasius Jefferson had contact with the Dallas Police Department in uniform on February 7, 2023, and the following are the circumstances surrounding the issue. I and my mother Kymberly Jefferson used to own a transportation company years ago, in 2021, we decided to give it another go at starting up the

business again. Out of the trucks we bought only two were feasible to bring back. The box trucks and a tractor and trailer were feasible vehicles. The tractor and trailer and one box truck were brought back to Dallas the other was sold in Florida where we bought them.

We found the only location at the time that had available parking for a tractor and trailer in Dallas which was T &S Truck Parking (they just recently changed names not sure of the current name now) which is located at 8723 S Central Expy, Dallas, TX 75241. The parking storage for Trucks is owned by a male by the name of Toby Hawkins.

Our Box truck was parked at a separate location and then eventually ended up at T &S due to our truck breaking down and a yard mechanic who worked for Toby by the name of Joe Lane stated he would help us out and get it fixed. At this time, we wanted to get the truck fixed for sale due to the demand and inflation in trucking was no longer worth it trying to start up a company from scrap.

Joe was supposed to be fixing a computer part on the box truck and replacing our batteries on the tractor and trailer. Joe had our truck for a while going from approximately summer into December and was paid funds. Nothing paid for on the truck was fixed.

In January we were put in contact with Toby (the owner) who stated he didn't know about Joe taking our money and not fixing the trucks and stated he would make it right and get it fixed. also, around this time my dad was in the hospital and passed away.

Toby who knew the stress we were under, he even offered to help us sell the box truck and tractortrailer to help ease some of the stress we were dealing with due to "feeling" bad about Joe ripping us off. In trusting him he collected our keys from both vehicles from Joe due to us not being able to reach Joe due to him not answering or being presently available.

During that time Toby eventually stated he had a buyer for the truck, and they wanted to close, due to us not having the titles yet from the Delay from the Texas State Department he decided that he would buy them and sell them to the potential owner when the titles came in. There was no transaction, bill of sale transfer of titles, or ownership until Toby's money cleared. On multiple occasions, we attempted to close the deal but would fall through due to his having insufficient funds.

This process of leading on went on for about a month, our trucks which aren't registered or in road condition to drive (DOT standards) were parked at the yard to our knowledge and no one had permission to drive or move any property of ours.

In February, my mom had a hunch something was going on with the trucks on the 6th we drove up there, and while up there someone was driving the tractor we own as we were pulling in. At the time we still owned the ruck and had not given anyone permission to drive our truck. My mother was furious because there was damage to the truck which wasn't originally there, and the vehicle wasn't operable per DOT to be on the road which gave concern due to if they hurt anyone it fell back on us. We Took video and contacted Toby about what was going on and he begged and



pleaded not to call the police that he would take care of it and that he had the means to finally close the deal. My mother decided to give him a last chance which he fell through again on February 7th today.

Incident February 7th: Around 15:33 hours today my mom texted me and advised we got taken again and nothing went through. My mom then called me around 16:48 hours from my sleep and advised something didn't feel right and that something may be going on with our trucks. I who was already getting up at around that time to get ready for work and left picked up my mom to go check on the trucks.

My mom felt weary and that our vehicles may have had something happen to them. She called Toby asking for the keys and he stated he couldn't due to being out of town. Due to his weird-acting nature, my mom wanted to go check to see if the truck was still there and to make sure everything was good, especially after finding out someone was driving it the previous day.

She was advised that I had to be at work and stated that I could drop her off at a family member's house in Lewisville after we left the yard. I had no plans of being out there long and did notify my on-duty commander of where I was going and that I may be a little behind just in case I was late. I picked up my mom who also lives in Garland we arrived at the truck yard and noticed our truck was there and still damaged and our trailer was missing that was supposed to be connected in the back.

The trailer was nowhere to be found on the lot or in our assigned spot. Our Trailer is a 56-foot 1996 Dorsey moving trailer (Exhibit A attached). There was a trailer connected to our truck that wasn't mine it appeared to be an enclosed 45-to-50-foot enclosed metallic trailer (Exhibit B attached). Due to my trailer being gone, and my truck still being used without my permission, I called DPD to make a report about the situation.

While on the phone, DPD 9dallas Police Department) was notified I was law enforcement due to them not understanding what I was trying to file and advised I was a cop and would be able to explain to them what offenses I thought were occurring if I could speak to an officer.

While on the phone the phone with 911, the owner Toby arrived shortly following (at that time I had no clue he was coming due to him stating he was out of town) and had my key to the truck, he was trying to have an individual move my tractor to get to a trailer that was connected to it. I asked for that not to happen and collected my key; I didn't want anything touched because I wanted the Dallas police department to see how everything was and I also believed something

suspicious was happening with the trailer and I didn't want my name connected to it. My mom had then again called 9 I 1 (unknown to me) because she felt his mannerisms were hostile, I didn't

notice due to walking away and trying to keep anything from escalating until 911 came. My mom felt nervous due to her finding out about his past after a few dealings with him and believed he

would possibly do something due to his history "she" was aware of. While on the phone Dallas police asked due to they heard him yelling at one point I needed "assistance" and officer code



which I replied no. I didn't feel the situation at the time needed it due to I was attempting to keep cool, calm, and collected and I knew they were on the way. Also, I did state it was raining and there was no need to have anyone running code at that moment. After refusing to move it and waiting for the Dallas Police Department Toby went back to the front office and came back in a side-by-side off-roading vehicle. Toby then kept saying he could purchase the truck and we could close the deal now.

Also pulled up was a red tractor day cab to connect to the trailer on my truck. While he was standing there multiple vehicles started speeding through the rocky dirt road headed towards our direction in the back of the lot, I looked at Toby and asked who those guys were, and he looked at me and shrugged his shoulders.

The look he gave me and the way the vehicles were advancing towards my location gave me an eerie feeling. My mom and I made eye contact and she stated let's go, I got in my truck and decided to leave because it looked like the situation was probably going to escalate. My mom stated she saw individuals in the vehicle with guns, I did not due to having tunnel vision in trying to leave but my mother is a pretty credible person with no criminal history.

As we were leaving the individuals began to speed up and follow us, the red tractor then made a loop and came around at a high rate of speed appearing to almost strike us on the side. At that moment my mom who was still on the phone with DPD.

I then stated that we were going to need help. I left and the vehicles followed on my tail, I eventually was able to lose them with aggressive driving and was advised of a nearby station that I could go to, where officers could meet me. Those individuals took red lights as I did and followed in the same direction as I did at a high rate of speed before losing them.

I genuinely believed due to the actions presented that something was off and was about to happen which is why at that moment I asked for help (assistance per dispatcher). I arrived at the South-Central substation where I met officers and explained the situation.

I was met immediately by a barge of officers with an African American sergeant taking primary. They separated me and my mother to ask us questions. The sergeant began to ask me questions about my incident, as I would start explaining what happened he would rudely jump in and then begin questioning my legitimacy as a police officer first asking for my credentials even

though I was uninformed because I was heading to work before all this occurred) then he would ask about my supervisors' information and other information about my agency.

The sergeant showed no care about what offenses may have occurred in the situation except for who I worked for. The sergeant was then going to walk off and I had to ask if was he going to

listen to the rest of what happened he continued for a bit then cut me to go speak with his higher up above him about my department. It appeared he was more interested in finding ways to

get me with the job than hearing me out about an abundance of things that occurred. I who was already stressed from the incident dealing with the death of an important family member started to become

overwhelmed. The sergeant then came back frustrated stating I had his units running code over a civil matter even though he never took the time to do due diligence to hear our criminal matter.

The sergeant then came back and stated he had guys at T & S truck parking, and they told him that the cars following us were not chasing us they were just leaving at the same time as us. My rebuttal to that was then if they were leaving why did they drive from the front to the back where it dead ends just to leave back to the front that a one way in one way out?

The sergeant couldn't give a good explanation then when asked about the truck trying to strike us, he stated the driver said he was driving fast through the parking lot and wasn't trying to. Why would you drive fast through a parking lot with potholes and lots of pedestrian traffic unless you were speeding to strike something?

The sergeant made it very clear he didn't want to help through his tone and body language. When asked about my trailer and why it wasn't there, he stated the guys in the yard said they moved it to another location and would bring it back. I never gave anyone effective consent to touch or move my trailer nor did I give them consent to move it to another location.

The sergeant I believe decided they would take an information report (not 100 % sure of the terminology used) but that was what it sounded like and stated that everything we had was a civil issue

Complainant Terasius Jefferson Statement cont.: Dallas failed us significantly, not only did we get stuck between a rock and a hard situation! Now my truck got stolen behind this situation and then my trailer got reported stolen and then we got arrested behind this whole situation.

Dallas failed us on multiple incidences. And the next time I come out My Department tells me not to go back out to that place unless DPD gives you civil stand-by. When I get Dallas out there my tractor is stolen now." "What if Dallas would have done their job appropriately in the first place!: None of my stuff would have been gone

Part C:

Complainant's Allegation: (1) My first complaint is I feel there was no true investigation into the ordeal of what occurred, and the sergeant failed to prevent the consequences of theft (my trailer). failed to investigate the unauthorized use of a motor vehicle.

Complainant's Allegation: (2) My second complaint is the unprofessionalism I experienced from the sergeant. From him failing to listen to me continuing to shut me down during my story because that wasn't his focus instead of waiting to get the info he needed after.



Complainant's Allegation: (3) My third complaint is against the assigned detective when getting my case I reached back out multiple times stating my email and other avenues to reach by so I can assist with getting my case done. The detective made no attempts to find alternative means to help assist me before closing the case.

Part D:

Complainant Jefferson Investigational Review Statement: "Everything I wrote there is pretty much solid of what my complaint is and what happened on both incidents. It has both Incidents on It has got both.in June." But they did not want to do an investigation on my truck because the guy stole it".

Dallas Police Department Internal Affairs Investigation Summary: The internal affairs division of the Dallas Police Department received your complaint. Submitted April 3rd. 2023. After a review of the information provided, we are unable to establish a violation of departmental policies or procedures as a result it is determined **no investigation** is warranted.

Office of Community Police Oversight: Special Investigator K.A. Williams conducted an Investigative review of complainant Mr. Jefferson's case.

Office of Community Police Oversite: Used evidence from the Dallas Police Department Internal Affairs Division, Officers Worn Camera Footage, DPD Incident Report, and Complainant Terasiuis Jefferson statements and information received by the complainant.

Part F:

Office of Community Police Oversite Investigative Facts: The Office of Community Police Oversite investigated the totality of the circumstances of complainant Mr. Terasius Jefferson's allegations of misconduct of Dallas Police Officers.

The Office of Community Police Oversite used evidence: provided by the Dallas Police Department Internal Affairs Division, Officers Body Worn Camera Footage, Complainant's interview Statements, Photos and information given by complainant.

Dallas Police Officers Body Worn Camera Footage Confirms: On February 7th, 2023. At 7:41 PM. Officers can be seen giving instructions, and professionally rendering service at two locations. The trucking location (Officers BWC) Video confirms) officer assisting the Jeffersons and during interaction with Dallas Police Department Lieutenant Adkinson at South Central Police Station (BWC Video) officers were engaged in gathering information from both Mr. Jefferson.

Mr. Jefferson Allegation: (1) Officers failed to investigate the unauthorized use of a motor vehicle. The Office of Community Police Oversite in its investigative review of all information gathered. Classify Mr. Jefferson's Allegations #1: AS NON-SUSTAINED cleared by Officer's Body Worn Camera.

Mr. Jefferson Allegation #2 Officers were Unprofessional while gathering information from Mr. Jefferson

The Office of Community Police Oversite in its investigative review of all information gathered. Classify Mr. T Jefferson and Jefferson's Allegations #2: AS NON-SUSTAINED cleared by Officer Body Worn Camera. DPD Officers can be seen clearly in BWC footage performing professional preliminary police investigational work.

Mr. Jefferson Allegation #3 The assigned detective was not responsive, and made no attempts to find alternate means to assist, before closing the case.

The Office of Community Police Oversite: confirms the Dallas Police Department Detective working his case. Made several attempts to contact Mr. Jefferson. DPD detectives made a professional effort to leave messages, to Mr. Jefferson for inquiries concerning his case.

The Office of Community Police Oversite classifies Mr. Jefferson's allegation #3 as UN-SUSTAINED.

The Office of Community Police Oversite Summary: Dallas Police Officers are well documented in BWC footage relaying information to the DPD A` Lieutenant. Stating "They have a VIN for the trailer". "The officers will give you a case number. Officer stated in the BWC video" We will take care of it. The Lieutenant states to Mr. Jefferson that I just notified your department, so they know of the situation. Lieutenant stated. "All you guys have is the civil matter"

The Office of Community Police Oversight Special Investigator concludes: On February 7th, 2023. that Dallas Police Officers were professional in interactions with the Jefferson's explaining every procedure taken.

Mr. Jefferson's three allegations against Dallas Police Officers are classified as UN-SUSTAINED. Officers body-worn camera documents Dallas police officers providing service and related information to Mr. Jefferson assisting him professionally.

The Office of Community Police Oversight Classifies: Jefferson Case NI-2023-317 A Civil Matter. No Officer Misconduct.

Part E: Office of Community Police Oversite Recommendations: The Office of Community Police Oversight recommends that no further action be taken and finds that this matter closed. Updated provided to complainant.



External Complaint Workflow Process



External Complaint Workflow No Investigation Sub-Classification General Definitions

It is the policy of the Department to accept and investigate all complaints of misconduct or wrongdoing from any citizen as prescribed by state law and Department policy. Complaints are handled in accordance with Texas Government Code, Section 614.021-614.023, as interpreted by the City Attorney.

A No Investigation (NI) number is assigned to information received in the Internal Affairs Division that does not meet the guidelines of a complaint requiring a full investigation by the Department. The information is given a sub-classification for statistical tracking purposes. The current sub-classifications used are:

- Does not meet criteria- Complaints relative to differences of opinion between a citizen and the investigating officer regarding the contributing factors listed on an accident report will not be investigated. If a person calls or comes in but does not want to provide a written statement at that time, it will be entered. If they fail to follow up and provide a written complaint In any format, it may result in this sub-classification.
- **Duplicate Complaint-** Person is making a repeated allegation that has already been handled by the department.
- Fail to Articulate- Person may be complaining but does not make an allegation of misconduct.

Guilt or Innocence-

- Complaints relative to differences of opinion between a citizen and an arresting
 police officer regarding the guilt or innocence of that citizen will not be investigated
 but will be properly disposed of within the judicial system. If a citizen can furnish
 evidence that the arrest was malicious and/or illegal, the complaint may be
 investigated at the discretion of the Internal Affairs Division Commander.
- Complaints relative to differences of opinion between a police officer and a citizen over the issuance of a traffic citation will not be investigated unless there is an allegation of a violation of law or departmental rules on the part of the officer.
- Information Only- A person may just be sending information or needing something from a
 member of the department. For instance, needing a detective to call them back about a
 case. A complaint about having to wait a long time for a police response to a 911 call may
 receive this sub-classification. Information is forwarded to division of responsibility.
- More Information- Person makes an allegation of misconduct, but the department needs more information to make determination on how to proceed.

- No Violation- Preliminary investigation is able to determine, based on evidence available, there is no violation of department procedures. Complaints involving a citizen's misunderstanding of departmental policy, which are resolved by a supervisor explaining the correct departmental policy and where the citizen is satisfied with the response, will not require investigation.
- No Violation BWC- Preliminary investigation is able to determine there is no violation due to review of officer's body worn camera.
- Non-Employee- Person makes allegation into misconduct of person who is not an employee of the police department.
- Sixty Day- Complaints are not typically accepted more than sixty days after the alleged incident, with the following exceptions:
 - When the complaint involves a criminal violation, the criminal statute of limitations will prevail.
 - When the complainant can show good cause for not making the complaint within the specified time limit.
- Third Party- Person complaining has no direct knowledge of incident. Often used when person sends an email or letter after seeing a negative news or social media story.

In all case, the citizen is sent a return letter to inform them that the information or complaint has been received and how it will be handled. If the department is not going to investigate, the reason is given with contact information on who they may call to discuss.
