5. deliberating the deployment, or specific occasions for implementation, of security personnel or devices. [Tex. Govt. Code §551.076]
6. discussing or deliberating commercial or financial information that the city has received from a business prospect that the city seeks to have locate, stay or expand in or near the city and with which the city is conducting economic development negotiations; or deliberating the offer of a financial or other incentive to a business prospect. [Tex Govt. Code §551.087]
7. deliberating security assessments or deployments relating to information resources technology, network security information, or the deployment or specific occasions for implementations of security personnel, critical infrastructure, or security devices. [Tex Govt. Code §551.089]

I understand the importance of addressing complaints promptly and thoroughly, and I apologize for any inconvenience caused by this delay.

Please be assured that I take all complaints seriously, and Internal Affairs Division is doing everything within their power to expedite the investigation while adhering to the requirements of the Family Medical Leave Act. I understand the frustration this delay may have on Mr. Lane and the community.

I appreciate the Community Police Oversight Board's dedication to ensuring transparency and accountability within our community.


The Dallas Police Department conducts thorough investigations into complaints alleging unreasonable force. We have established protocols and procedures to address such complaints promptly and fairly. The Public Integrity Unit and the Internal Affairs Division are responsible for investigating these matters, ensuring that they are handled with the utmost professionalism and impartiality.

I understand the importance of addressing concerns related to the most polarizing issue in law enforcement, use of force by officers, and I take these allegations seriously. Our existing procedures are designed to thoroughly investigate each complaint, gather all relevant evidence, and make fair determinations based on the facts presented. We are committed to upholding the principles of transparency and accountability in our investigations. The Office of Community Police Oversight has the availability to monitor these external investigations.

While I appreciate the Community Police Oversight Board's recommendation, I believe that our current procedures are effective in addressing complaints alleging unreasonable force. We have a dedicated team of professionals who are trained to handle these matters appropriately and ensure that any misconduct is addressed accordingly whether administratively or criminally. The Dallas Police Department has also leveraged an independent subject matter expert to provide a use of force analysis. The Police Force Analysis System provided by Police Strategies, along with an interactive dashboard, can be located on the Dallas Police Department website.

I believe that by engaging in a constructive dialogue, we can address any concerns and work together to ensure the highest standards of accountability and transparency.

On August 18 2018, at or around 5:40am. Senior Corporal Moody and Officer Ortega were dispatched on a major disturbance call at 1411 Exeter Avenue. A suspect, Diamond Ross, was located and placed under arrest on an outstanding warrant. Ms. Ross appeared under the influence through her interactions with the police, though she would not state what, if any, illegal substances or alcohol she had consumed. Ms. Ross resisted arrest with physical force, but officers were able to subdue her and place her in the back of the police car. Once in the car, Ms. Ross continued to act erratically and attempted to escape by kicking the windows of the car. Ms. Ross was removed from the car and Senior Corp. Moody instructed Officer Ortega to place her body weight on the diaphragm of a resisting suspect in order to be subdue them once fatigue set in. They proceeded to execute the maneuver and were able to subdue Ms. Ross again. Prior to transport, Senior Corp. Ross had Dallas Firefighter Rescue perform a check of Ms. Ross and Dallas Fire Rescue cleared her for transport.

While attempting to place Ms. Ross back in the car, Senior Corp. Moody observed Ms. Ross was unconscious but breathing and moving her foot. Ms. Ross was taken to holding where she was placed in a wheelchair until she was ready for processing. Once she was ready for processing, personnel attempted to wake Ms. Ross but she was nonresponsive. After attempts to wake her failed, Senior Corp. Moody requested medical assistance from Dallas Fire Rescue and Ms. Ross was transferred to the hospital. Ms. Ross died. the Medical Examiner determined the cause of death was an accident due to the toxic effects of phencyclidine (PCP).

An administrative investigation was conducted in 2019. Further, the case was presented to a Dallas County grand jury, by the Dallas County District Attorney's Office. No bill of indictment was returned by the grand jury.

The administrative investigation concluded that while the Ms. Ross died from PCP, there were sustained allegations against Senior Corp. Moody and Officer Ortega. Specifically, the sustained allegations were:

- Officers Failed to Secure Prisoner with a Seatbelt.
- Officers Failed to Secure Prison with a Seatbelt
- Officers Failed to Obtain Medical Treatment

Senior Corp. Moody was recommended for a 1-2 day suspension. Senior Corp. Moody was issued an official written reprimand. Officer Ortega was recommended for Advice and Instruction. Officer Ortega resigned while under investigation.

## INVESTIGATION

### OFFICER TESTIMONY

**Senior Corporal Larry Moody, #9291, Northeast Patrol Division (Affidavit in Any Fact dated September 25, 2018, Internal Statement dated May 8, 2019, and Supplemental Statement dated May 9, 2019)**

*(At the time of this incident, Senior Corporal Moody was assigned to the South Central Patrol Division.)*

On August 18, 2018, Senior Corporal Moody responded to a major disturbance call at 1411 Exeter Avenue with Officer Ortega, who was a third-phase recruit. Mr. Johnny Brown met Senior Corporal Moody and Officer Ortega at the front of the residence. Mr. Brown explained that Ms. Ross was staying at his residence and was consistently coming to his residence around 5:00 a.m., causing disturbances. Ms. Ross had punched out the cardboard trimming around the A/C unit of his bedroom window. After she punched out the window, she walked across the street to the neighbor's residence. When Ms. Ross returned, Mr. Brown confronted her. Ms. Ross had two cellphones in her hand, one of which belonged to Mr. Brown. Mr. Brown grabbed his cellphone, which appeared to be slipping out of Ms. Ross's hand. Ms. Ross began "freaking out" and grabbed Mr. Brown's shirt, which was ripped off during the physical altercation between them. Mr. Brown showed Senior Corporal Moody and Officer Ortega a six-inch-long scratch on his left arm that he claimed Ms. Ross caused during the physical altercation. After the altercation, Ms. Ross went to a bedroom and Mr. Brown called for police.

Senior Corporal Moody and Officer Ortega entered a room where Ms. Ross was lying on a bed. Officer Ortega attempted to interview Ms. Ross and she refused to answer. While Officer Ortega was attempting to obtain Ms. Ross's information, Senior Corporal Moody asked Mr. Brown what type of drug Ms.

## FINDINGS

### CLASSIFICATION OF ALLEGATIONS

Allegation #1 – **SUSTAINED** – Failed to secure prisoner with a seatbelt.

Allegation #2 – **RESCINDED** – Failed to take proper action.

Allegation #3 – **SUSTAINED** – Failed to secure prisoner with a seatbelt.

Allegation #4 – **SUSTAINED** – Failed to obtain medical treatment.

### CONCLUSION

Based upon the testimonial, video, and documentary evidence collected during the course of this investigation, **Allegations #1 and #3**, stating that on August 18, 2018, Senior Corporal Larry Moody, #9291, and Police Officer William Ortega, #11359, failed to secure a prisoner with a seatbelt during transport, are classified as **“SUSTAINED.”**

DVR footage documents when Officer Ortega and Senior Corporal Moody began their transport of Ms. Ross to CDC, she was not secured with a seatbelt. The transport lasted approximately 17 minutes and Ms. Ross was observed moving around the rear passenger compartment of the vehicle and lying down on her back during transport. Ms. Ross was able to place her feet on the back of the seat with her head on the prisoner partition, facing backwards.

Senior Corporal Moody stated that generally, the female officers who search female prisoners usually seatbelt the prisoner to prevent a male officer from having to reach over the prisoner. Officer Ortega stated it was an oversight on his part because he assumed other officers had put the seatbelt on Ms. Ross when she was placed in the squad car.

As a result, Officers Moody and Ortega should be held accountable for the following rule violations:

## BACKGROUND

On Saturday August 18, 2018 at approximately 0648 hrs DPD Cpl. Moody, assisted by a second unknown DPD officer came to the CDC to submit Diamond Ross (B/F 01-01-1984) for arrest book-in processing. During the initial book-in process DSO Latarsha Borders found the prisoner to be unresponsive and notified SDM Briggs. Subsequently, Cpl. Moody examined the prisoner and notified DPD dispatch via two-way radio to send an ambulance to the CDC for arrestee Ross.

Upon arrival DFR examined the arrestee Ross and started emergency medical treatment. At approximately 0717 hrs DFR Rescue #6 transported arrestee Ross to Baylor University Medical Center. It should be noted that Cpl. Moody and his partner were allowed to leave the CDC before the on-duty staff had identified the second officer or obtained officer Moody's badge number. This officer's identification will be established at a future date and entered into the record at that time.

At approximately 1000 hrs SDM Briggs received notification from DPD that arrestee Ross was brain dead. SDM Briggs then notified the investigating officer.

At approximately 1100 hrs the investigating officer arrived at the CDC. All CDC surveillance audio and video footage associated with this incident were reviewed and an evidentiary DVR made. All CDC personnel on duty at the time of this incident were interviewed and written statements were taken (attached).

The review of the audio and video footage associated with this incident gave no indication of arrestee Ross being assaulted or mistreated after arriving at the CDC.

## TIMELINE OF EVENTS

06:48:47      DPD arrives at the CDC with A/P Ross.

06:49:33      DPD Cpl. Moody, assisted by his partner, remove A/P Ross from the backseat of their patrol car and lay her face down on the pavement. A/P Ross was handcuffed with her hands at the rear of her back. A/P Ross does not appear to be conscious.

06:51:08      DPD Cpl. Moody, assisted by his partner, pick A/P Ross up using her forearms and her lower legs and carry her to the door of the CDC.

06:51:47      Cpl. Moody and his partner enter the secure gun locker storage area and place A/P Ross face down on the floor as they secure their weapons.

You violated Chapter III, Section 3.2 of the Dallas Police Department Code of Conduct and Section 300, Section 313.13 (A)(5) of the Dallas Police Department General Orders on August 18, 2018, when you failed to secure Ms. Ross in the back seat of the squad car with a seatbelt during transportation.

You violated Chapter VI, Section 6.3 of the Dallas Police Department and Section 801, Subsection (D)(1)(4) of the Dallas Police Department Patrol Bureau Standard Operating Procedures on August 18, 2018, when you failed to notify DFR and obtain medical treatment for an unresponsive prisoner.

By the authority delegated to me by the Chief of Police, you are hereby issued this Letter of Reprimand. A copy of this reprimand will be placed in your file and a notation will be made in your file in the Internal Affairs Division. Any future violation by the Police Code of Conduct, City Personnel Rules, or departmental rules or regulations issued by the Chief of Police, will result in the appropriate penalty for such violation, and may result in more severe disciplinary action as provided in Section 2.2 of the Police Code of Conduct, which provides that failure to comply with any rule or regulation of the Department subjects the offender to disciplinary action, including dismissal from service.

If you wish to appeal this reprimand, you must, within ten (10) working days from receipt of this letter, demand a hearing before Executive Assistant Chief David Pughes. Such demand must be made in writing to the Executive Assistant Chief in care of Major Reuben G. Ramirez, Internal Affairs Division; otherwise this reprimand will become non-appealable.

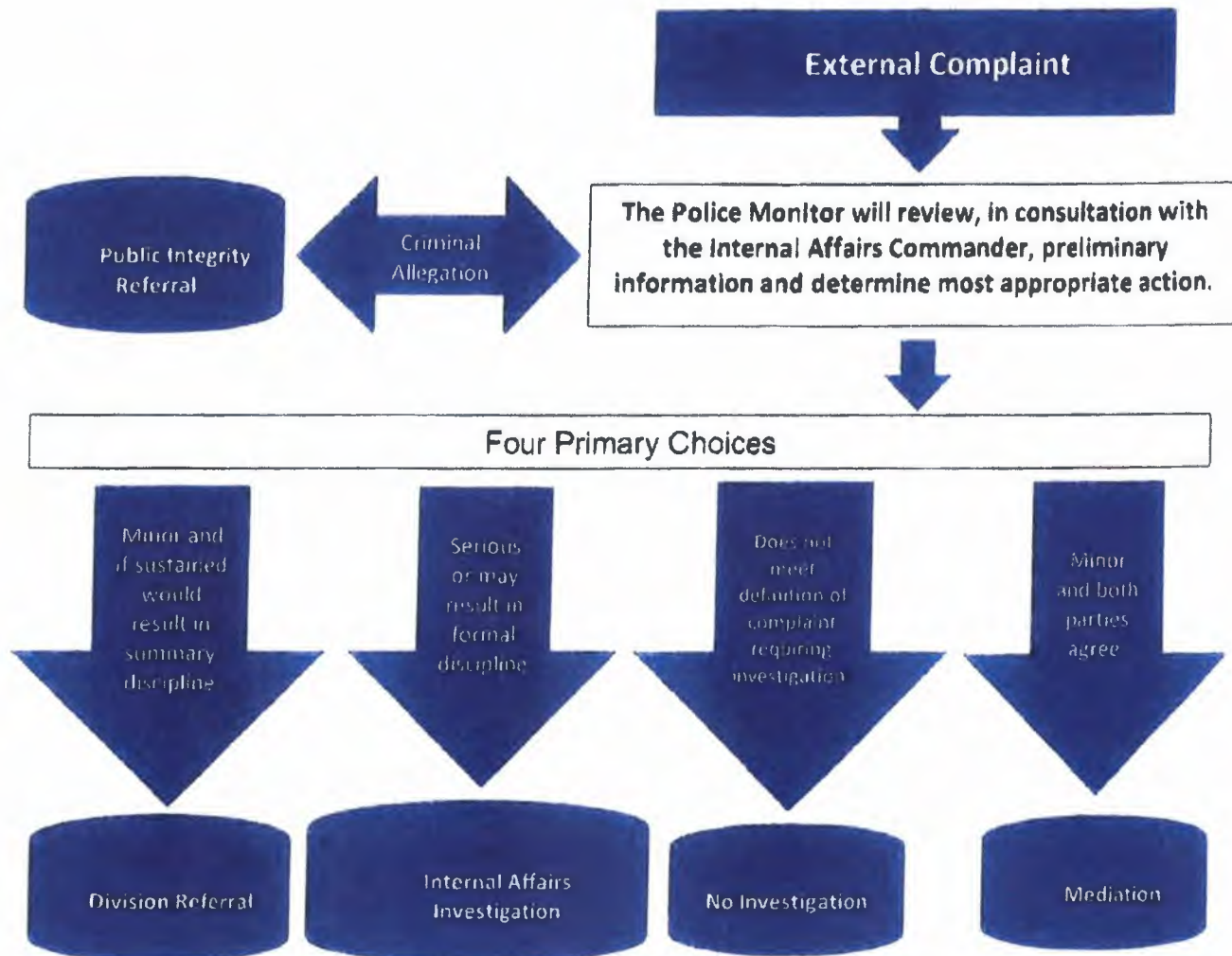

## External Complaint Workflow

### No Investigation Sub-Classification General Definitions

It is the policy of the Department to accept and investigate all complaints of misconduct or wrongdoing from any citizen as prescribed by state law and Department policy. Complaints are handled in accordance with Texas Government Code, Section 614.021-614.023, as interpreted by the City Attorney.

A No Investigation (NI) number is assigned to information received in the Internal Affairs Division that does not meet the guidelines of a complaint requiring a full investigation by the Department. The information is given a sub-classification for statistical tracking purposes. The current sub-classifications used are:

- **Does not meet criteria-** Complaints relative to differences of opinion between a citizen and the investigating officer regarding the contributing factors listed on an accident report will not be investigated. If a person calls or comes in but does not want to provide a written statement at that time, it will be entered. If they fail to follow up and provide a written complaint in any format, it may result in this sub-classification.
- **Duplicate Complaint-** Person is making a repeated allegation that has already been handled by the department.
- **Fail to Articulate-** Person may be complaining but does not make an allegation of misconduct.
- **Guilt or Innocence-**
  - Complaints relative to differences of opinion between a citizen and an arresting police officer regarding the guilt or innocence of that citizen will not be investigated but will be properly disposed of within the judicial system. If a citizen can furnish evidence that the arrest was malicious and/or illegal, the complaint may be investigated at the discretion of the Internal Affairs Division Commander.
  - Complaints relative to differences of opinion between a police officer and a citizen over the issuance of a traffic citation will not be investigated unless there is an allegation of a violation of law or departmental rules on the part of the officer.
- **Information Only-** A person may just be sending information or needing something from a member of the department. For instance, needing a detective to call them back about a case. A complaint about having to wait a long time for a police response to a 911 call may receive this sub-classification. Information is forwarded to division of responsibility.
- **More Information-** Person makes an allegation of misconduct, but the department needs more information to make determination on how to proceed.

- **No Violation-** Preliminary investigation is able to determine, based on evidence available, there is no violation of department procedures. Complaints involving a citizen's misunderstanding of departmental policy, which are resolved by a supervisor explaining the correct departmental policy and where the citizen is satisfied with the response, will not require investigation.
- **No Violation BWC-** Preliminary investigation is able to determine there is no violation due to review of officer's body worn camera.
- **Non-Employee-** Person makes allegation into misconduct of person who is not an employee of the police department.
- **Sixty Day-** Complaints are not typically accepted more than sixty days after the alleged incident, with the following exceptions:
  - When the complaint involves a criminal violation, the criminal statute of limitations will prevail.
  - When the complainant can show good cause for not making the complaint within the specified time limit.
- **Third Party-** Person complaining has no direct knowledge of incident. Often used when person sends an email or letter after seeing a negative news or social media story.

In all case, the citizen is sent a return letter to inform them that the information or complaint has been received and how it will be handled. If the department is not going to investigate, the reason is given with contact information on who they may call to discuss.
