Handgun Prohibition Notice for Meetings of Governmental Entities

SUBJECT: Lane Investigation Update

Part A: Background

Mr. Lane filed a complaint with DPD on June 3, 2023. After reviewing the case IAD determined that the case would be classified as a “No Investigation” because they “were unable to establish a violation of departmental policies or procedures.”

After receiving the results of the investigation from DPD’s Internal Affairs Division (IAD), Mr. Lane filed an appeal with the CPOB. At the August 8, 2023, CPOB meeting, the Board reviewed the complaint of Mr. Dynell Lane and voted for OCPO to do an independent investigation into the case.

OCPO was in the process of beginning their investigation when it received an email from Major Irene Alanis who is the commanding officer in charge of IAD stating, **“Be advised, I have opened an investigation on Mr. Lanes EC2023-0603 complaint.”**

Part B: Status of the OCPO Independent Investigation & Next Steps

Since the September CPOB meeting, OCPO is actively monitoring the IAD investigation of Mr. Lane’s complaint. At the February 13, 2024 meeting, Major Alanis informed the board that the chain of command was in the process of making decisions regarding disciplinary action.

SUBJECT: Dynell Lane Case Delayed Adjudication and Disclosure Issues

To the Honorable Councilmembers of the City of Dallas and the City Manager,

First, on behalf of the entire Board, I want to thank the city for its continued commitment to the mission of the Community Police Oversight Board and the role we provide to the community. Your support has been an invaluable aide to our pursuit of providing transparency and accountability to the citizens of Dallas regarding the Dallas Police Department. We have set ambitious goals for our oversight objectives in the coming year and look forward to working as a board to best represent the citizens of Dallas.

With that said, the Board is sending this official letter to you to voice our frustration regarding the Dynell Lane Administrative Complaint Investigation. At our February 13, 2024 meeting, the Board and the community expressed unanimous frustration with the adjudication process for this case. Obviously, public scrutiny on this matter is especially high given the media attention the released body worn camera footage generated. However, regardless of the case's media attention, the delay in the adjudication process for the Lane case represents a larger systemic issue that we must address. The type of recorded violation that allegedly transpired in the Lane case should not require a prolonged process to make a disciplinary determination. It is clear to the eye of any reasonable citizen, that what allegedly transpired in the recorded video is a violation of the standards we hold for our officers.

Moreover, due to the need to protect sensitive information and preserve due process for accused officers, DPD has not been able to be as forthcoming and frank in disclosures. The current restrictions on disclosures to the Board and the public leaves the Board ill-equipped to accomplish its mandated duty of transparency in cases like the Lane case. The delay and lack of information provided has been unacceptable.

The Board should be able to know IAD's determination on whether a violation occurred once IAD's investigation is complete. In Lane, as well as many other cases, IAD's determination is reached within 45 days of the adjudication process, but that determination is withheld by DPD until final disciplinary action is taken. The discipline process can take additional weeks and months to complete. During that time, the Board is unable to provide the public or complainant with basic information about the determination.

Therefore, the Board is officially requesting your intervention to address these issues for DPD's complaint adjudication process and ensure the Board is equipped to provide prompt and appropriate transparency about determinations.

SUBJECT: Case No. 023295-2024 Critical Incident Shooting Wheatland Rd.

On February 11, 2024, an officer involved shooting occurred at 2984 West Wheatland Road. Police responded to a armed robbery call at approximately 12:37 am at a local office space that was being used as an illegal gambling room. This is the first officer involved shooting of 2024. Suspects, Reginald Curry and Horice Williams, are alleged to have entered the gambling room with multiple weapons in an attempt to force the operator and patrons to give them all the money in the establishment. Police received multiple 911 calls from patrons inside the establishment to respond to the scene.

When police arrived, the first suspect, Mr. Curry, exited the establishment. Police identified themselves and gave commands to the suspect. The suspect then brandished a firearm and fired several rounds at police officers. The officers took cover and began returning fire while the suspect began to evade police on foot. The suspect continued in the fire exchange with police, taking cover behind vehicles in the parking lot. While the suspect was engaged in the fire exchange, other firearms fell from the suspects pockets. The suspect attempted to escape by running through the parking lot while still turning to engage in the fire fight. Officers struck the suspect in the leg and the chest area. The suspect finally collapsed in the drive through lane of an Arby's connected to the parking lot. Officers approached, disarmed the suspect, who was responsive, and placed him under arrest. Upon placing the suspect under arrest, officers immediately began providing medical aide until an ambulance arrived at the scene. This was a non-fatal police shooting and the suspect was taken to a medical center for further medical care.

While officers were in pursuit of the first suspect, police dashcam captured the second suspect, Mr. Williams. escape on foot through the front door of the establishment. The following day, Mr. Williams was arrested by police for his involvement in the armed robbery. Mr. Williams

was in possession of an illegal firearm at the time of his arrest.

Sergeant Dragija #8877, Officer Froman #12266, Officer Anderson #12296 were the officers directly involved in the shooting incident. Sargent Hampton #8481 handled the investigation of the critical incident. A video has been uploaded to the Share Point with the footage.

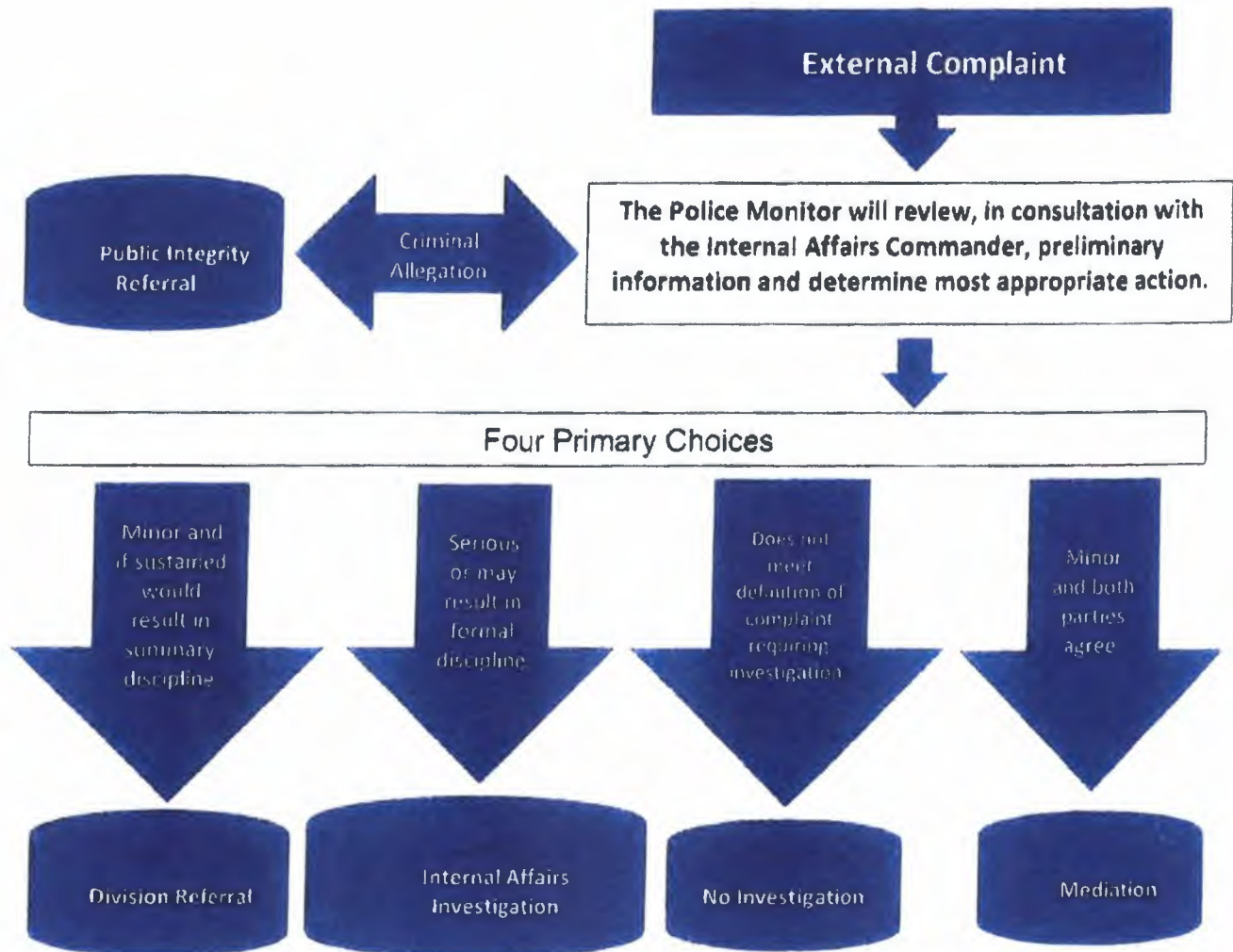

No Investigation Sub-Classification General Definitions

It is the policy of the Department to accept and investigate all complaints of misconduct or wrongdoing from any citizen as prescribed by state law and Department policy. Complaints are handled in accordance with Texas Government Code, Section 614.021-614.023, as interpreted by the City Attorney.

A No Investigation (NI) number is assigned to information received in the Internal Affairs Division that does not meet the guidelines of a complaint requiring a full investigation by the Department. The information is given a sub-classification for statistical tracking purposes. The current sub-classifications used are:

- **Does not meet criteria-** Complaints relative to differences of opinion between a citizen and the investigating officer regarding the contributing factors listed on an accident report will not be investigated. If a person calls or comes in but does not want to provide a written statement at that time, it will be entered. If they fail to follow up and provide a written complaint in any format, it may result in this sub-classification.
- **Duplicate Complaint-** Person is making a repeated allegation that has already been handled by the department.
- **Fail to Articulate-** Person may be complaining but does not make an allegation of misconduct.
- **Guilt or Innocence-**
 - Complaints relative to differences of opinion between a citizen and an arresting police officer regarding the guilt or innocence of that citizen will not be investigated but will be properly disposed of within the judicial system. If a citizen can furnish evidence that the arrest was malicious and/or illegal, the complaint may be investigated at the discretion of the Internal Affairs Division Commander.
 - Complaints relative to differences of opinion between a police officer and a citizen over the issuance of a traffic citation will not be investigated unless there is an allegation of a violation of law or departmental rules on the part of the officer.
- **Information Only-** A person may just be sending information or needing something from a member of the department. For instance, needing a detective to call them back about a case. A complaint about having to wait a long time for a police response to a 911 call may receive this sub-classification. Information is forwarded to division of responsibility.
- **More Information-** Person makes an allegation of misconduct, but the department needs more information to make determination on how to proceed.

- **No Violation-** Preliminary investigation is able to determine, based on evidence available, there is no violation of department procedures. Complaints involving a citizen's misunderstanding of departmental policy, which are resolved by a supervisor explaining the correct departmental policy and where the citizen is satisfied with the response, will not require investigation.
- **No Violation BWC-** Preliminary investigation is able to determine there is no violation due to review of officer's body worn camera.
- **Non-Employee-** Person makes allegation into misconduct of person who is not an employee of the police department.
- **Sixty Day-** Complaints are not typically accepted more than sixty days after the alleged incident, with the following exceptions:
 - When the complaint involves a criminal violation, the criminal statute of limitations will prevail.
 - When the complainant can show good cause for not making the complaint within the specified time limit.
- **Third Party-** Person complaining has no direct knowledge of incident. Often used when person sends an email or letter after seeing a negative news or social media story.

In all case, the citizen is sent a return letter to inform them that the information or complaint has been received and how it will be handled. If the department is not going to investigate, the reason is given with contact information on who they may call to discuss.
